### Library of Things debuts at Crete library

The Crete Public Library is spicing up its options for borrowing with a Library of Things collection. Collection items are available for checkout starting this week.

Library of Things collections feature any items that are not book-related or thought of as what would typically be offered for checkout at a library. The Crete collection is sponsored by the Friends of the Crete Public Library nonprofit organization.

Library Director Joy Stevenson said LoT collections have become more popular in recent years, and each place that has one them puts its own spin on what its collection offers.

The library worked with the Friends of the Crete Public Library to determine what items it wants to offer in its collections. It put out a survey featuring possible LoT collection items, and about 100 respondents indicated how likely they would be to borrow each one.

If more than half of the respondents said they would definitely or possibly be interested in borrowing an item, the library added it to the collection.

The collection currently includes a telescope, coffee urn, ice cream maker, electric knife sharpener, Kill-A-Watt monitor,

metal detector with headphones, mini donut maker, portable carpet cleaner, portable sewing machine, radon detector, roaster oven, warming server, thermal imaging camera, jigsaw puzzles, cake pans and beverage dispensers.

"I was very much looking forward to the electric knife sharpener, because it's just the perfect item, I think, in the Library of Things," Stevenson said. "You only need to borrow it maybe once a year, and you only need it for a couple of days, otherwise it takes up space in your

## \$48K CHS gym speakers paid for by booster club advertising

At the Jan. 23 Crete Board of Education meeting, the board approved a new speaker system for the Crete High School gym that will cost \$48,408.

Dr. Josh McDowell, Crete Public Schools Superintendent, said the current sound system is significantly under-engineered for the Crete gym.

"The gym gets used so frequently for classes, graduation and sporting events," McDowell said. "It's not functioning well, doesn't sound well and it's hard to understand talking and music. The board felt it was necessary."

Although the project is going to cost \$48,408, a lot of the project is going to paid for by revenue made from the video boards.

"They will cover more than half of the expenses," McDowell said. "The other roughly 40% will come out of the building fund."

McDowell said some of the speakers in the gym are still usable, so those will go to the softball fields.

"We're really trying to create a great student and fan experience, and we're excited that the board wanted to move in that direction," he said.

The school will be going through Yandas Music and Pro Audio and is hoping the project will be done in February.

"We're on their list and we hope we can get it done ASAP," McDowell said.

McDowell said they really wanted to do the project because they wanted to give people the best experience after all the time and investments the community has put into CHS.

"When the community has invested in as much as they have into the facilities at Crete, we want the whole experience to be outstanding," he said. "We teach a lot in that gym and have phenomenal community support for our sporting events and graduation. It's a great investment and will provide the best experience possible."

### District court rules BOA erred in Milligan 1 lawsuit

After waiting since Nov. 1, 2023, the Saline County District Court Judge David J. A. Bargen made a ruling in the Milligan 1 vs. Saline County lawsuit.

On Jan. 11, Bargen ordered that the board of adjustment ruling on July 25, 2023, that imposed a sound limit on a Milligan 1 turbine be vacated.

The matter came before the district court on Nov. 1 when the plaintiff, Milligan 1 Wind, LLC, requested a judgment on the pleading or summary judgment be granted by the court. Saline County admitted the adjustment board's July 25, 2023, decision imposing sound limits on the plaintiff's wind farm operation should be vacated.

After hearing the Milligan 1 and the county's' arguments, admissions and considering the relevant pleadings, Bargen found Milligan 1's motion for judgment on the pleadings should be granted.

"Milligan 1 had asked for a more expansive order (summary judgment) that would have required the board of adjustment to vote to rescind the order and prohibited the county from ever imposing any noise regulations on these wind turbines," said David Solheim, county attorney. "The county opposed such an expansive order, and the court agreed."

Bargen also noted Saline County answered Milligan's amended complaint on all defendants' behalf, which named the board of adjustments and Lyle Weber in his official capacity.

"The reason is that although any person aggrieved by any decision of the board of adjustment ... may present to the district court for the county a petition ... specifying the ground of the illegality" it is "the county board (that) shall file an answer to the petition which shall admit or deny the substantial averments of the petition and

### Musicians Hall of Fame inductees recognized at all-day polka party

Polka rang out to the dirt roads surrounding Tabor Lodge on Jan. 27.

The 25th annual Musicians Hall of Fame took place at the Dorchester dance hall this weekend. The event celebrates polka music, kicking off with a three-hour accordion jam and closing with performances from two live bands.

In between the live music are the inductions into the Musicians Hall of Fame, an honor currently held by 144 current and former performers. Each fall, a committee comprised of past inductees votes on who will be introduced into the hall the next year.

Five people were inducted this year: Frank "Red" Jisa Jr. and Bruce "BJ" Fictum posthumously, as well as Frank Siedlik, Timothy Popsisil and Tony Sydzvik.

The induction came as an honor to the long-time musicians, invoking both humor and emotion in their acceptance speeches.

"In playing the horn I tell people that all I do is blow hot air and push three buttons," Popsisil said. "But I'm glad that everybody enjoys it so much. I am very honored and thankful for this. You folks sitting around here are the reason that I play."

When accepting his award, Siedlik took the moment to think of those in the polka community that could not be there to see him inducted.

"I've been playing a long, long time," Siedlik said. "I've loved every minute. I've met a lot of great musicians. I had the pleasure of sitting alongside and playing with a lot of them that are gone now. But I won't forget them."

The event was organized by Randy Korbelik, Deb Polacek

and Sue Placek, all of whom are in the hall of fame. It all began back in 1997 when a polka music celebration was organized for the passing of Randy's older brother, Ron, an accordion player in many bands and the hall's first inductee.

'That went over pretty good," Korbelik said. "So, we decided to have another party and dance the second year, and then the next year we started making it the Musicians Hall of Fame.

Fans of the genre from towns across Nebraska make the drive out to Dorchester yearly to enjoy all the event has to offer. Couples shuffled across Tabor Hall's dance floor for nearly the entire nine hours with moves that proved it was hardly anyone's first time.

With a long history of Czech heritage in the area, it is also a way to keep a culture many attendees grew up with alive.

"We've all been around polka music most of our lives," Polacek said. "This event is great because it brings so many people together and keeps that spirit of the Czech culture going.<sup>2</sup>

It is just the third year that Tabor Lodge has hosted the event, as Ron's Tavern was the annual spot for its first 22 years. They allow the committee to use the hall for free and will continue to hold the celebration for years to come.

The night ended with polka performances from the Leo Lonnie Orchestra and the Little Tavern Band.

Apace, Usher has worked in a group home, in supervised apartments and as a relief filling in for others. She was then the assistant to the residential coordinator before coming into her current position.

I still miss the old cartoon of Calvin and Hobbes.

One day they were discussing the growing interest in angels. Calvin says, "I think angels are everywhere." "You do?" says Hobbes. "Yes," says Calvin. "They are on calendars, books, greeting cards, almost every product imaginable."

And Hobbes responds, "My, what a spiritual age we live in!"

Many people claim to have an interest in spiritual concerns. Many people would say they have faith in God. The problem I see is folks who claim to have faith but they don't put the teachings of the faith into practice. Many people would say they believe in forgiveness but they don't forgive much.

### Committee hearings begin in the legislature

The 108th Nebraska Legislature wrapped up day 17 of our 60-day session last week. We have completed bill introduction as well as the rules debate, and have begun having public hearings and full floor debate on legislation.

Last week, we advanced LB16, which is a bill aimed at removing obstacles and simplifying licensing processes for various professions facing significant workforce shortages. Additionally, LB461, designed to ensure responsible use of taxpayer dollars in government contracts by considering factors beyond just the lowest bid, advanced to the second round of debate.

The intention is to avoid instances where low-bidding contractors fail to deliver on promised services, such as what happened with St. Francis foster care program a few years ago.

We had our first two hearings this week regarding bills that make relatively simple changes. First, LB900 was heard in the Transportation and Telecommunications com-

mittee. What this will do is increase the maximum length of a truck from 40 feet to 45 feet, which brings us in line with all the surrounding states.

I would like to thank Geneva Mayor Cody Lightwine for bringing this legislation to us, and for coming up to the Capitol and testifying on the bill. He did a great job at explaining to the committee members how this affects Nebrakans like him.

Our second bill, LB938, would make some much-needed updates to the County Purchasing Act. This was held in the government committee, and would increase the thresholds relating to county purchases and the selling of surplus property. This proposal outlines circumstances under which competitive bidding may be waived, ensuring flexibility in response to emergencies or when substantial cost savings can be realized through special purchases or auctions.

An example of this would be if a road grader was up for auction on Big Iron (an online auction site), a county board may pass a resolution stating that they can bid up to an agreed amount for the equipment and not have to take the time to put out a request for bids.

I would like to thank Jefferson County commissioners Mark Schoenrock and Gale Pohlmann, and Fillmore County Supervisor Wade Sluka for coming to testify and their online comments.

Kozak said he no longer had a job at the local coop, so he went to work for Crete Mills, where he worked the next 42 years before retiring in 2007.

One of his fondest memories of his military service was being asked to take part in an honor flight to Washington D.C., where he got to tour the capitol with other service members.

"It was quite a deal," he said. "We really had a nice welcoming event when we arrived, and it was quite a honor to be able to be there."

## Have we gotten soft?

You would never know it now, but as a kid, the great outdoors dominated any time I had between playing baseball and mowing lawns for baseball card money.

There was hardly a day go by that I didn't fish or hunt, depending on the season. Now, my fishing pole is collecting dust.

We fished for anything that would bite on a worm or some worn-out lure. There were the bullhead ponds where you knew the fish would bite. The local lumberman had a club-member-only pond where you had to be patient and find the right spot for the bass to hit your lure.

A couple of friends and I even got caught skinny dipping by a couple of high school girls at the club pond.

We'd travel to Harlan County and fished the trees for crappie or troll the dam for walleye. Once a year, my family and my cousin, Mike Wenz's family, traveled to Valentine National Refuge. If we were tired of trying to catch perch, the kids would put a boat in a farmer's lake and catch bullhead two at a time.

During the week, my stepmother, Mae, would buy a six pack of Shiltz beer. Not for the taste but for the free Daredevil fishing lure. Then we'd find our way to a local pond where the farmer had stocked it with Northern Pike. If she felt sorry for the boys on a hot day, we'd get to sample the Schlitz.

The winter meant hunting. When I was 12 years old, Santa

brought me a single-shot 16-gauge shotgun. Dad took us out that Christmas Day. I shot and hit the first two rooster pheasants I scared up. I thought I was a terrific shot. My mistake. It took two more years before I rustled another feather on a bird.

The most memorable hunting we ever did was when my brother, Roger, our friend, Randy Sagehorn, and I would go hunting from sunup to sunset. We were too young to drive, so we made sure we had plenty of shotgun shells. We would take off on foot to find those elusive rooster pheasants.

Here's where the story gets good. Randy had a black lab named Blacky. Real inventive, right. Blacky was a good hunting dog. We seldom lost a pheasant that we shot from the sky.

The problem with Blacky was he would run in corn fields when he sensed a pheasant. Back then, all the farmers picked their corn. There were lots of stalks and places pheasants could hide. It was a great place to find the hungry birds.

When Blacky would take off down a corn row, so would we. It was impossible to train Blacky to slow down, so we adjusted. The three of us would sprint to the end of the field carrying our shotguns and running in heavy boots. I'm not sure how many pheasants we shot, but we were in great shape.

In the 1960s when I was growing up, you never heard of a snow alert or wind chill warning. If we had a free Saturday, the three of us would take off from Randy's house in search of pheasants, quail, rabbits or even jackrabbits.

The weather sometimes made us stop early, but we never backed away from getting into the field. The worst weather the three of us ever experienced was one Saturday when the temperature was minus five degrees with at least a 15 mile an hour wind.

We bundled up and headed south. No experienced hunter would face the wind until the temperature reached zero. It was about a mile into the hunt when the first pheasant flew up right in front of me.

My fingers were numb but it would be tough to miss this easy shot. However, the gun didn't make a sound. The safety had frozen on and I couldn't get it shoved forward. We did the only sensible thing experienced hunters would do. The three of us turned into that cold north wind and headed back to Randy's house.

The only reaction from our parents was surprise that we had come home so early. They certainly didn't voice any concern for our safety. If that went on today, our parents would have been hauled off to jail for child abuse.

That's proof we have gotten soft.



Korbin Kunc, 9, cherishes the bonds he forms with the animals he and his family raise on their farm just west of Wilber. He feels the loss of

them just as strongly. Melanie Kunc said her

son has been raising cattle his whole life and started showing with 4-H when he was five. She said he is naturally talented in showing and won awards in his first year participating.

He never seems worried about anyone else in the ring, though. He is simply dedicated to bettering himself.

When Korbin shows, it's just him and his animal," Kunc said. "He doesn't care who's watching, and he doesn't care if his animal isn't as good as everyone else's. He's competing against himself, and that's what sets him apart. I think that extra spunk is going to take him places in life.' Korbin has always had a special love for animals. Last year, he got to show big show heifers for the first time. He participated in his final show in his age bracket in November, and Kunc remembers seeing tears in his eyes as he walked into the ring. "This big old animal, an 1,100-pound breeding heifer or bigger, could

Nine-year-old Korbin Kunc experiences love, loss of raising animals



A few weeks ago, Winnie gave birth prematurely and had a stillborn. Kunc said she seemed depressed afterward and the Kunces paid close attention to her as they tried to determine what was wrong. They then noticed swelling in her jaw and took her to the veterinarian where she was diagnosed with a high altitude disease.

Her body was filling up with fluid from the inside out.

Winnie contracting the condition was just bad luck and there was nothing they could have done to prevent it, Kunc said. The family knew it was only a matter of time until she died, so Korbin made sure she received extra attention during her last days.

'We've been loving on her, and Korbin spends a lot of time out there talking to her and visiting ner and petting ner, Kunc said. Kunc said this is not the only tough hand her son has been dealt over the past few months. The Kunces purchased a new horse and watched her fall and break her leg in September. They had to put her down, and Kunc said Korbin took it pretty hard. Watching Korbin struggle with the loss of an animal reminded Kunc of her own experiences on a farm as a child. Her heart was always drawn to animals that needed extra care, and she said she remembers feeding a little black calf in her family's barn when she was just two and a half.

"Korbin has kind of got that same spirit of, if it needs saved or needs taken care of, I'm here to serve," she said. "That big heart aspect is really evident in Korbin, and I just really appreciate that about him."

Kunc said losing an animal is a heartbreaking experience.

"It's such an important thing, though, in the world we live in, for these kiddos to understand the humanity of it and realize you're not in control. A life is a life, and once it's gone you don't get it back," Kunc said. "People don't grow up learning that and embracing that.

"So, despite the sadness and challenges, I'm very appreciative for those opportunities for my kids.<sup>3</sup> Winnie died the afternoon of Jan. 18. Kunc said although her life was cut short, Korbin gave her the best one possible. "That little guy has taken immaculate care of her, and you can just tell when she stands there and looks at him like, 'I love you," she said. "There's always an ending, and, I guess, just like a person, you can't focus on the ending. You have to focus on the in between."

literally kill your kid. But they're their buddy, and they respect them," she said. "The lessons that every individual animal teaches your child are so different from animal to animal."

One of Korbin's most beloved pets was Winnie. The Kunces bought Winnie, a bucket calf, when Korbin was 6 years old. Kunc said she had no mother, so Korbin took on that role. He eventually began showing her in 4-H competitions.

"Bucket calves don't typically grow well. They're typically a little behind and a little disadvantaged. But, he raised her, and she did very well for him," Kunc said. "She grew nicely. She was a stinker though— he learned a lot from her because she wasn't always cooperative."

## Soybean farmers encouraged to apply for board position

This year, the Nebraska Soybean Board will be seeking farmer-leaders to represent fellow soybean farmers in Districts 1, 3 and 6. The candidacy petition period began on Dec. 1 and concludes on April 15.

District 6 includes Saline and Seward counties.

"Farmer leadership is crucial to NSB and submitting a candidacy petition is a powerful way for farmers to actively shape the future of our soybean industry," Andy Chvatal, NSB executive director, said. "District directors contribute directly to the decision-making processes, ensuring a collective and impactful representation of our industry."

Qualified candidates include those who are a resident of Nebraska, are at least 21 years old, reside in the district where the election is being held, have been a soybean farmer in Nebraska for at least the previous five years and have submitted an NSB candidacy petition.

To apply for candidacy you must:

• Obtain an NSB candidacy petition by contacting NSB's executive director, Andy Chvatal, at (402) 441-3240 or andy@nebraskasoybeans.org.

• Complete the petition and collect the signatures of 20 soybean farmers in your district.

• Return such petition to the NSB office on or before April 15, 2024.

District directors' roles and responsibilities include: •Manage and conduct the business of the Nebraska Soybean Board.

• Uphold the core values of integrity, leadership,

collaboration, adaptability and innovation.

• Attend five annual board meetings (typically held in September, November, January, March and June/ July). These meetings are required and are one to two days in length.

• Participate in trade missions, work with the media, represent NSB at events, meetings and more.

• Serve on two of the four NSB committees each year. These committees provide strategic direction regarding board decisions.

• Serve a three-year term that will begin Oct. 1, 2024.

Soybean farmers who reside in counties that are up for election in 2024 will receive ballots and candidate information regarding NSB's election process via direct mail.

## Tabor Lodge: Historic dance hall kept alive by its members

Just off the intersection of dirt roads in Dorchester is a white building with over 100 years of history.

That building is Tabor Lodge, a meeting hall complete with its own bar and dance floor. Since being built in 1914 on a plot of land bought for just \$101, it has hosted countless events such as weddings, polka concerts, and even Czech language plays.

It is run by volunteers from the community, who do everything from bartending to bookkeeping.

Founded by 14 Saline County residents of Czech descent, the lodge served as a meeting place for locals to celebrate the Czech culture and heritage in the town. Czech language classes used to be taught at the lodge, along with a Sokol gymnastics program.

Its connection with the country can be traced all the way back to its name,

that makes it really special to me."

The lodge is currently affiliated with BetterLife Insurance. When one takes out an insurance policy with the company, they become a member of the lodge. Monthly meetings are held in the building for members. The current president is Dorchester native Gary Veprovsky, who lived in a house just a half mile down the road from the lodge as a child. He grew up regularly attending events with his parents Emil and Shirley, who served as the lodge's vice president and treasurer. respectively.



And even when he wasn't in attendance, he always knew when others were.

"In the summer, when my windows were open, I could hear the music and people from my bedroom," Veprovsky said.

Like many other Dorchester residents, the lodge has played an important personal role in Veprovsky's life. He had his wedding celebration there when he married his wife, Penny, as did their daughter, Melanie, when she got married. Larry Fuller, the lodge's treasurer, is another current member who hosted a wedding reception there.

"It is a family thing," he said. "Me and my wife celebrated our anniversary there as well, which others have also done."

While they are less frequent than when Veprosky got married, Tabor Lodge still hosts around two weddings and anniversaries a year.

with "Tabor" being the Czech word for "camp."

Marlene Stehlik has been a member and worked at Tabor Lodge for more than 40 years and has seen first-hand the way it kept its heritage alive over the years.

"Everyone would go to the polka dances and bring their kids with them," she said. "That's where they learned Czech heritage. That's something

Nowadays, the lodge is still rented out for private events and hosts annual events such as a cornhole tournament in February. On Saturday, Jan. 27, from 2 - 10 p.m., the Musicians Hall of Fame induction will be held there for the fourth year in a row, with the event ending in a five-hour polka dance similar to those that the lodge started out hosting.

## Term limits on Congress resolution filed in Nebraska

State Sen. Loren Lippincott (Dist. 34) has filed Legislative Resolution 282 (LR282) for Nebraska to join the states calling for a convention to propose a Congressional Term Limits Amendment to the U.S. Constitution.

Fourteen state lawmakers committed their support by signing a pledge to cosponsor Sen. Lippincott's resolution, Senators Ballard (district 21), Bosn (district 25), Brewer (district 43), Clements (district 2), DeKay (district 40), Dorn (district 30), Erdman (district 47), Halloran (district 33), Hardin (district 48). Holdcroft (district 36), Lowe (district 37), Meyer (district 41), Murman district 38), and Wayne (district 13).

By using Article V of the U.S. Constitution, 34 state legislatures can team to call a convention to propose a congressional term limits amendment. The effort is being spearheaded by the nonpartisan, nonprofit, U.S. Term Limits.

The President of U.S. Term Limits, Philip Blumel, commended Sen. Lippincott for working on such an important election reform.

"The people of Nebraska are lucky to have public servants who see what is going on in Washington, D.C., and are willing to take action to fix it," Blumel said. "By using Article V to term limit Congress, the states can restore citizen representation on Capitol Hill." According to the most recent Nebraska Statewide Congressional Term Limits poll by RMG Research, there was 82% support from Republicans, 79% support from Democrats and 63% support from Independents.

Once LR282 passes the state legislature this

session, Nebraska will put Washington, D.C. on notice that it intends to join other states in calling for a convention for the exclusive purpose of proposing term limits on the U.S. Congress.
