

### January

Longtime Fayette mail carrier William "Doc" Acton was honored for nearly 27 years of service with the U.S. Postal Service. Starting work in his native Glasgow, Doc shortly afterward transferred to Fayette as a clerk-carrier and later became a full-time carrier. Fellow postal employees, family members and friends were on hand to honor him with a cake and other recognitions.... With bitter cold and upward of 6 inches of snow recorded here, Howard County along with much of the nation's midsection is enduring the most severe blast of winter weather since about this time last year. All Howard County schools were closed Monday January 10.... A 52-year-old Armstrong man died Friday January 7 apparently from a self-inflicted gunshot wound. Howard County Sheriff Charlie Polson said that he and several deputies responded to a 911 call around 9:15 p.m. at 103 N. Evans St. There they discovered the body of William A. (Bill) Doiron who recently had moved to Armstrong from Columbia. Others present in the house said he and his girlfriend had been having trouble in a relationship and reportedly Doiron used a 12-gauge shotgun to kill himself in front of the woman. Doiron was pronounced dead by Howard County coroner Frank Flaspohler.... In a development that is being hailed as good news at Central Methodist University here, Missouri Gov. Jay Nixon announced late this week that the Missouri Depart-

ment of Higher Education will increase scholarship amounts for students under the Access Missouri program. Many CMU students rely on Access Missouri grants since they help to make college affordable and thus promote choice in selection of the institution best suited for them. A judge has ruled in favor of the Howard County Ambulance District in a lawsuit between the district and the Howard County Sheriff's Department. The case was heard in the circuit courtroom here. In comments after the trial, Saline County Associate Circuit Judge Hugh C. Harvey strongly encouraged cities and the county in the future to work out the details concerning liability for medical expenses of arrested persons. He said the present county policy-which places liability of medical expenses onto the arresting agency-could conceivably jeopardize the safety of citizens for two reasons: 1) it encourages municipalities to call a sheriff's deputy instead of dealing with an issue directly and 2) a person in the county jail, whether formerly charged or not, could "fake" a medical condition, be released and then assault another person. The county is ordered to pay the ambulance district \$1,400.... Gathered in a special called session, members of a steering group spearheading the erection of a massive Santa Fe Trail monument in Howard County hailed word that a major grant will speed the project to completion. A Trans-

portation Enhancement Grant from the Missouri Highway Department has been awarded for \$111,000 which means that the monument now will be a reality. Making the announcement was New Franklin Mayor Frank Frevert who also noted that arrangements have been completed to move the renovated Katy caboose to near the monument site. The caboose is now next to the Highway 5 stop-sign in downtown New Franklin.... Charles O'Neal, 25, pleaded not guilty to murder and assault charges in the Randolph County Courthouse be-

fore Circuit Judge Scott Hayes. Also on, Hayes recused himself since he was involved in invalidating O'Neal's previous guilty plea. The Missouri Supreme Court will assign a new judge to the case. Once a new judge is assigned, trial dates will be set to take place in the Randolph County Circuit Courtroom. After O'Neal pleaded guilty, was convicted and imprisoned for the murder of Dawn Kelly, 37, on Feb. 10, 2007, he claimed his attorneys were ineffective and had given him faulty legal counsel. Hayes heard O'Neal's claim in April and determined

that O'Neal had proven that he was given faulty advice by his lawyers. O'Neal's guilty pleas in the homicide were declared invalid. O'Neal agreed to be charged on first degree murder, first degree assault and two counts of armed criminal action with the provisions that both a jury trial is waived and the death penalty will not be sought by the prosecuting attorney, Kevin Zoellner of the Missouri State Attorney General's office. O'Neal is currently being held in the Howard County Jail on a \$1 million cash-only bond

### February

Stories of the Blizzard of '11 will likely be handed down for generations to come. Howard County residents joined with much of the rest of the nation this week as the heaviest snowfall in at least 15 years hit here and elsewhere. A thin layer ice blanketed the area beginning Jan. 31 and by shortly after 7 a.m. on Feb. 1, snow began to fall at the rate of about 2 inches an hour. Total accumulation measured here varied from about 14 to 18 inches. As blizzard conditions hit the area Feb. 1, virtually all schools, government offices and businesses were forced to close. Totally impassable road conditions forced cancelation of the regular Fayette Advertiser issue of Feb. 2; it is believed to be the first time in the history of the Fayette papers that an issue has been canceled. The Advertiser has been combined into today's Democrat-Leader. I-70 across Missouri was closed for the first time in the history of I-70....Hopes of convincing New Franklin-based Jennings Premium Meats to remain in Howard County for a planned expansion were dashed last week when it was officially announced that the company will build a \$2.5 million facility in Boonville "in the near future." The 16,000 squarefoot operation will process meat snacks and employ about 20 persons. Jennings will continue to offer custom butchering and retail meats at its New Franklin facility. The new facility is planned for the Boonville Mid-America Industrial Park near Interstate-70 and Highway 5.... Longtime Fayette alderman Jan Addison has been appointed mayor of the city following the unexpected resignation of Mayor Joe Bex on Jan. 18. She is believed to be the first woman mayor in the history of Fayette since its founding in 1823. The action came Feb. 8 at the regular meeting of the city council, a meeting that had been postponed from Feb. 1 because of inclement weather.... Charles O'Neal, 25, was assigned a new judge on Feb. 4 by the Missouri Supreme Court. Russell E. Steele, presiding judge in the 2nd Judicial Circuit (Adair, Knox and Lewis counties) will hear O'Neal's case in the Randolph County Courthouse.... James Clatworthy, a Fayette native who continued his family's longtime ladies ready-to-wear business into more than seven decades on the town square here, is dead at 73. Better known as Spider, he died unexpectedly under hospice care early Feb. 11 at Glasgow's Golden Living Center. Clatworthy had been transferred to the facility only the day before after being discharged from Boone Hospital Center. Clatworthy had been in ill health in recent years. Death is believed to have come from a cancerous growth which had metastasized to several vital organs. A longtime business and civic leader here, Spider had closed the venerable store in July 2009... On Feb. 12, Fayette city council members passed an ordinance which gives greater tax breaks to new and expanding businesses. The county and all its municipalities had already passed tax abatements for new or

expanding businesses in 2009. JoAnn Sumner, county economic developer, had proposed greater tax abatement rates so the county could offer a stronger incentive for potential businesses. ... The Fayette Advertiser and Democrat-Leader will have a new publisher effective Feb. 16, marking the first change in ownership in more than a decade. Nebraska native Patrick L. Roll, 53, has purchased the newspaper operation from James H. Steele who had been editor-publisher since December 2000. Closing paperwork was scheduled to be completed at 3 p.m. on Feb. 15. Roll and his wife, Ruth, moved to Fayette several weeks ago from Herman, Neb., and reside in the former Wanda Buckler home on Highway 5/240 across from the Fayette Golf Course. After more than 18 years in the newspaper business in Nebraska and Iowa, Roll said he has long wished to own his own publication. He has lived most of his life in small, rural communities such as Fayette and both he and his family are attracted to small-town values.... Debra Miller, a well-known and much beloved community leader here, was honored Saturday evening, Feb. 12, as Fayette's 2011 Citizen of the Year. The announcement came during the annual Town and County banquet. Miller has served as director of Faytte's Endless Options since 1997, a service facility serving special need adults. Under her leadership, a recycling program is now available for the citizens of Howard County while EO clients gain work experience in the program.... New Franklin school, church and civic organizations recently received more than \$300,000 from the estate of the

late Dan and Marie Ray, longtime New Franklin residents.... Charles O'Neal, 25, will receive a trial Dec. 1 and 2 on charges of first degree murder, first degree assault and two counts of armed criminal action....Fears of a possible building collapse have prompted Fayette city officials to close the alley behind the former IGA building on the east side of the town square. For the last 12 or 14 years the structure has housed a mostly-vacant furniture storage facility known as Colonial Mercantile, in addition to an apartment on the second floor.

Jim Bensman, engineer with MECO Engineering Co., inspected the collapsed wall on the east side of the Colonial Mercantile Building on Feb. 28. He had already observed the structure before the east wall collapsed on Feb. 23 and had made observations concerning the roof. He submitted a report of his findings to the Fayette city council which reviewed the report at their regular meeting on March 1. He stated the buildings at 103 and 105 N. Main St. "should be considered unsafe and dangerous according to several sections of the city of Fayette municipal code." Other key findings include: Portions of the east brick wall appear to be unstable and dangerous due to the lack of support. As portions of the brick wall continue to fall, other parts of the wall and possibly the roof may collapse. The roof is bowed and has water pooling on it adding weight that is not intended to be supported by the structure. City crews have fenced off the alley behind Colonial Mercantile....Leslie M. (Jake) Greiner, a well-known former Fayette resident with a distinguished career spanning more than six decades in education, military service, civic affairs and state government, is dead at 91. Col. Greiner died Saturday at his home in Lee's Summit... A man suspected of burglaries which happened in February in rural Howard and Boone counties is now in custody in the Howard County Jail. Michael Wayne Schouten, 35, was arrested by Howard County Sheriff's deputies Tuesday evening at 405 W. Elm St. During questioning, he confessed to burglarizing residences along Highway 124 on Feb. 23. He also confessed to breaking into and stealing from five storage units located along Highway 240. Schouten had pawned the stolen items at Boonville and Columbia pawn shops. Working with the Boone County Sheriff's Department, the Howard County Sheriff's investigators found items which matched the descriptions of stolen items from Howard and Boone County homes. They were able to identify who pawned the stolen items and were led to Schouten...Approximately 25 residents of the Armstrong area met at City Hall at 6 p.m., March 7 to learn more about the new City Hall/Senior Center to be built there within the coming months. Steve Gerrish of the U.S.D.A., Moberly office was present to explain the financing for the building and Michael Kettlekamp of A. Kettlekamp Architects of Hannibal was on hand with the plans for the new structure. A 30 by 60 foot building will be built on a vacant 50' x 100' lot donated to the city by the Dale Huber family at the corner of Central Street (Route #3) and Haley Street across from the Post Office. The Armstrong Revitalization Committee has been working on this project for several years. A stimulus grant from the U.S.D.A. in the amount of \$145,985 will in part make this possible. The City also applied for a state grant, but that was turned down due to lack of available funds. A donation from the Markland Family of \$30,000 brought life to the project that

was thought impossible. The city added funds and a loan for approximately \$16,000 to be paid off over 30 years which will complete the funding of the handicapped accessible building.... New Franklin council members have joined other Howard County entities in endorsing an increase in tax breaks to new or expanding businesses. Their action taken Monday, March 14, at their regular meeting will allow the county to apply for Enhanced Enterprise Zone status....The Fayette School board approved the Fayette Athletic Booster Club football field entrance project. FAB started raising funds for the project after Jay and Kelly Jacobs made a donation that in part helped renovate the football field. At this time, the FAB has raised

all the funds necessary to complete the entrance to the football field... Four areas of town were rezoned from single-family residences to multiple-family residences at a special meeting of the city council on March 15. One rezoned property gained more attention than others because a significant contingent of individuals were opposed to the change. City hall was full with about 20 persons present. Most in attendance voiced opinions about a proposed rezoning of property along East Elm between Louisiana and North Mulberry. Pam Huttsell, chairperson of the Planning and Zoning Commission, reported that P&Z had voted 3 to 2 to recommend changing the zoning status from RS-1 (single-dwelling residences) to RS-3 (multiplexes

and single-family residences). In other words, if approved, the area would be zoned for apartments as well as single-family homes. Huttsell noted that the builder, Sedalia based Furnell Companies, plans to spend \$900,000 to erect two eight-plexes with one to three bedroom apartments. A 28-vehicle parking lot is planned. Rents would range from \$400 to \$550 a month. Furnell has a good reputation for constructing attractive and affordable housing, according to Huttsell. Furnell built Ashby Heights in Fayette. Huttsell believes rental property would be good for the community. "It will increase the tax base, increase the number of electrical customers for the city and provide affordable housing for college students and young

Work continues on the new city park water tower. Chicago, Bridge and Iron of Illinois is constructing the 500,000-gallon water tank for \$1,137,000. The

upgrade is part of Fayette \$3.6 million water distribution project. The project includes modification of Givens Tower (done) and the laying of 6,100 feet of new pipe along Park Road, Besgrove and Church Streets. Funding came from USDA-Rural Development and the Community Development Block Grant program....

## **April**

Peggy and Joe Guest want to recreate Fayette's iconic popcorn wagon that was a warm-weather fixture on the town square during much of the first half of the 20th century. To generate interest and funds, they have constructed a miniature replica of the wagon based on a photo provided by Jim Steele, former editor/publisher of the Democrat-Leader. The wagon had begun life as a horse-drawn hearse, and boasted beveled crystal windows, polished flower vases, gas lamps and ornate carving. Converted into a popcorn wagon sometime around the World War I period, it was parked at the northwest corner of Main and Davis Streets where customers bought nickel bags of popcorn. Peggy and Joe learned about the wagon last fall when a Fayette Flashback featuring the wagon appeared in this newspaper. With encouragement from others, they decided to pursue a recreation of the memory of the wagon. "We don't want it to be a museum piece. We want it to be used," Peggy Guest said in an interview with a Democrat-Leader at the Uriel Wright Building, where the replica was on display.... Fayette resident Chad Sulltrop, 31, died from injuries sustained in a logging accident in Monroe County. According to Monroe County Sheriff Dave Hoffman, Sulltrop was in the woods logging when a friend, who was operating a skid loader, notified authorities he discovered Sulltrop was unconscious after it appeared a tree had fallen and hit him on the head. The accident happened north of Madison off Route K....R. Henry Summers, a well-known businessman and civic leader in Howard County for more than seven decades, died April 5, at the Fayette Caring Center of age-related infirmities. He would have been 94 on April 25. A longtime resident of Fayette, he was at the forefront of many significant civic and church projects here, especially in the 1950s, '60s, '70s and beyond. His business interests included feed and fertilizer sales, grain elevators, insurance and real estate... With fewer than 15 percent of eligible residents casting ballots in April 5 election, Howard County voters overwhelmingly approved a 1/8-cent sales tax for 911 upgrades, rejected a school district boundary change and turned out a longtime incumbent on the Fayette school board. Tal-

lying of votes in the courthouse here was completed shortly after 8:15 p.m. Tuesday. The number of votes cast was 1,162 out of 7,880 registered voters. A surprise took place in balloting for the Fayette school board where four candidates were in contention for three open seats. By a margin of only four votes, challenger Brian Asbury defeated longtime incumbent Charles Moore....A New Franklin police officer resigned April11 after being arrested for driving while intoxicated and supplying alcohol to minors...Ryan Schuler, 43, of New Franklin, was arrested shortly after midnight by the Missouri State Highway Patrol. Schuler was taken to the Howard County Jail where he posted a bond and was released. Following the arrest on, Schuler told Chief of Police Dave Wells that he intended to resign. Wells

received a written resignation from Schuler on April 11at about 11:30 a.m...Referred to as a "milestone," all three entities of the Howard County Regional Water Commission have passed ordinances which authorize purchase of water from the Howard County Regional Water Commission (HCRWC). Their combined actions give a green light to the building of a water plant in southern Howard County that will supply water to the cities of Fayette and New Franklin and to the customers of the Consolidated Public Water Supply District No. 1 of Howard County. At two separate meetings, the city council of New Franklin and the board of the CPWSD#1 of Howard County authorized taking on the debt of the Howard County Water Commission and committed to purchase about 198,700 million

gallons of water combined annually. They join the city of Fayette which authorized the water contract with the HCRWC on April 5. The combined actions will make way for the HCRWC to proceed with the construction of a water treatment plant near New Franklin and distribution lines to serve water customers of Fayette, New Franklin and the CPWSD#1. Key provisions of the water contract: All three entities commit to paying for a minimum amount of water from the Howard County Regional Water Commission. All three entities will be responsible for the payment of the Water Commission's debt (about \$6 million). The debt is being financed by a 35-year loan from USDA....State and local officials gathered April 15 in Glasgow to announce the arrival of a new manufacturing operation which is expected to

Jud Evans, Jon Held and Ken Hendrix take the oath of office April 18 at the regular meeting of the New Franklin School Board. With a combined 45 years of service on the New Franklin school board, Joe Chitwood, Todd Hill and Jim Hull each decided to not seek re-election leaving three seats open for newcomers Evans, Held and Hendrix to fill. The three retiring members were honored with presentations of plaques and words of appreciation....Leon Hackley, Kenneth O'Brian and Larry Dimond took the oath of office April 19 at the regular meeting of the Fayette city council. Hackley was elected as a write-in candidate for the southwest ward. O'Brian easily won re-election for the east ward. Dimond had been appointed and then elected to the northwest ward....The Fayette Board of Education swore in reelected members Gary Gose and Sheri Williams and newly elected member Brian Asbury. Dr. Paul Schoephoerster was elected as President of the Board and Tim Jackman was elected as Vice President of the Board. Superintendent Jim Judd recommended — and the Board approved a revision of the Transportation Program for the 2011-2012 school year. The revised policy

scales back the extent of transportation services....With a gallon of gas costing \$1.06 more today than at this same time last year, everyone driving a vehicle or purchasing goods of any kind knows that living costs have risen significantly. Every household has noticed that when the end of the month comes around the paycheck is not going as far as it did earlier. There doesn't seem to be any relief in sight. Howard County Sheriff's Department deputies responded to an alleged drowning accident which was said to occur off of Franklin Island. They made contact with Michelle L. Miesner, 43, of Stover, who said her boyfriend, Robert T. Gabauer, 44, had apparently fallen into the river. She told deputies that she and Gabauer were fishing on the island when she heard him fall into the water, shout a few times

and then heard nothing more. With further questioning, Gabauer and Miesner are reported to have admitted a false drowning claim with the intent of collecting on life insurance. They were brought to the Howard County Jail, where they remain on a \$30,000 cashonly bond.... In regular session on May 9, the Harrisburg school board unanimously approved to change the school week to four days for the 2011-12 academic year. Students will attend school from Tuesday through Friday during the week, and as a result, the school day will be extended.... Howard County ranks within the top quartile of counties within the state on a recently-released County Health Rankings list. The annual report comes from the Wisconsin Population and Health Institute and the Robert Wood Johnson Foundation. Overall, Howard county ranks No. 27 among Missouri's 114 counties and the City of St. Louis....The Boonville city council voted 7 to 1 to accept

They have verbally told city officials of their plans to open a convenience store with gas pumps.... Traffic is flowing again on Highway 124 in Howard County. At approximately 7 o'clock June 13, MoDOT opened the new bridge over the Moniteau Creek. It is four feet wider and will accommodate two-way traffic.... Wearing T-shirts with large letters that said "CMU Cares," a group of more than 70 Central students, staff, faculty and alumni departed for Jo-

The rate increase will go into effect Aug. 31. For an average household of four who use 5,000 gallons a month, the sewer rate will increase by \$1.25 per month... Longtime church and civic leader William L. (Bill) Fisher, a trailblazing public servant who went on to become Fayette's mayor, has died at age 74. Although he had suffered from heart and circulatory problems in recent years, Fisher's death was unexpected. He was found dead in his home early. The previous weekend he had assisted with the annual Fayette Juneteenth Celebration....A former Howard County man pleaded guilty in federal court to operating two cattle fraud schemes in which 28 victims, including The Callaway Bank in Fulton as well as numerous individuals lost nearly \$8 million. Kevin Ray Asbury, 44, formerly of Howard County, waived his right to a grand jury and pleaded guilty before U.S. Magistrate Judge Matt J. Whitworth to federal information that charges him with bank fraud, wire fraud and money laundering. By pleading guilty, Asbury admitted that he was involved in two separate fraud schemes, both of which involved his cattle business, R&K Angus Ranch in Howard County, from December 2006 to October 2008. Asbury's business included soliciting investors throughout the United States to pay a portion of the purchase price for cattle, which he would raise and sell. Investors then received a predetermined return from the sale of that cattle. Both of Asbury's fraud schemes involved false and fraudulent statements that he owned, bought and sold cattle when, in reality, he had not done so....The Fayette City Park Swimming Pool, which will celebrate its 75th anniversary this Fourth of July weekend, is one of two above-



## July

During a brief visit to Glasgow Gov. Jay Nixon's message may have been obvious, but it was rendered of great importance to those listening at Stump Island Park. "The message we're trying to send today is there's a lot of water coming," Nixon said. He addressed those in attendance while standing at the park's shelter house, roughly 100 feet away from the floodwaters of the Missouri River. Part of the park has been closed to the public because of the recent flooding, which has covered the park's basketball court. Glasgow was the second of Nixon's three stops Thursday during a survey of flood conditions along the Missouri River. His first stop was at Levasy where he flew by helicopter to Glasgow, before making his final stop in Henrietta later that evening. Nixon was on hand to meet with local officials to discuss preparations for rising water....Grand marshals Bill and Martha Holman help kick off Fayette's Fourth of July activities during the parade through Fayette City Park. The day's festivities included a parade, car show, pony rides, free swimming at the Fayette City Pool and a sand volleyball tournament.... The 2011 Miss Howard County is Nazow Tarakai . Bryce Callahan and Preslee Sunderland were crowned 2011 Howard County Prince and Princess on Wednesday at the Howard County Fairgrounds. The two helped present awards during the Queen and Teen contests as well. Following the Queen and Teen announcements, all 10 participants gathered on stage for pictures at

the conclusion of the contests.... New Franklin city council members opted to withdraw financial support of the Howard County Economic Development Council in the 2011-2012 budget. The city

had previously contributed \$1,000 toward the effort. The city joins the city of Glasgow which recentwithdrew funding for HCEDC.... The electric plant superintendent position has been eliminated following an executive session of the Fayette city council July 5. Robert "Bobby" Gerlt, who was hired in 1985 and began as superintendent in 1988, was released from employment by the city Tuesday... Though the future is bleak for the state's transportation funding, a new state five-year highway construcprogram tion approved Wednesday by Missouri Highways and Transportation

Commission. But the new program is only half the size of recent years. It is about \$600 million a year rather than the average

of \$1.2 billion. There's barely enough money to take care of the existing system, and Missourians will see very few new projects during the next few years that expand the system and make it



safer.... Bonnybrook Steel Forms, which began its operations in Glasgow in April, shipped its first order .Elliot James, Bonnybrook plant manager, said the first order was for a company located in the greater Chicago area, AMTI. Fowler was presented with a picture and ribbon from ceremony held on April 15....After more

than 20 years as a physician in Fayette, the medical director of the MU Family Practice Clinic here has decided it's time for a change. Paul Schoephoerster, M.D., confirmed to the Democrat Leader that he will step down on Sept. 28 to join the Boone Hospital Center system in a new practice family clinic in Columbia that will be located near the main hospital campus in that city. He will begin work Nov. 1. Dr. Schoephoerster will continue to reside in Fayette. "I love this community and its well-being is very important to me and my family," he said. "We're totally committed to remaining here and to seeing our boys graduate from Fayette High School."... After more than four decades at the helm

of the Fayette Star Coronet Band, Bob Bray has decided to step down. In an emotional farewell to musicians assembled for the annual Roanoke Band Concert, Bray said "My body is telling me it's time to quit."...A New Franklin man has been charged with operating two methamphetamine labs on his property. On July 23, Howard County Sheriff's Deputies Jeff Glandon and Nate Stoebe stopped a pickup truck on HoCo Road 442. They made contact with Timothy A. Renfrow, 30, of New Franklin. They observed a five-gallon bucket of anhydrous ammonia in the pickup bed. Renfrow was taken to the Howard County Jail and charged with possession of anhydrous ammonia in an unapproved container. While in the jail, Renfrow gave permission for law enforcement to search his property on HoCo Road 442. The Mid-Missouri Drug Task Force were called to assist. Upon searching the premises, law enforcement found two methamphetamine labs on the property. Renfrow was subsequently charged with two class B felonies of manufacturing a controlled substance and a class D felony of possession of anhydrous ammonia. His bond was set at \$50,000 cash-surety. On July 26, Renfrow posted 10 percent bond and was released.... The U.S. Postal Service is conducting a study of nearly 3,700 post office branches across the nation, including two offices located in Howard County: the Armstrong Post Office (left) and the Franklin Post Office (right). Most of these offices are under review because they're located in rural areas with low business volume. The agency hopes to save approximately \$200 million per year with the closings in an effort to withstand its increase of money-losing retail operations.

## August

Kicking off the 11th Annual Howard County Relay for Life in traditional fashion, local cancer survivors — wearing purple Tshirts and a "Cancer Survivor" sash — walked around the courthouse square during the Relay's opening lap. Following the survivor lap, Relay for Life teams walked around the square throughout the evening and later attended a pizza party at Breadeaux Pizza. In addition, there was plenty of entertainment, a silent auction, a "Celebrity of the Relay" contest and several other activities that took place throughout the night.... At their regular meeting, the Fayette city council changed the zoning status of a trailer court on Reynolds Street. As a result of the council's decision, Central Methodist University plans to purchase the property. At the recommendation of the Planning and Zoning Commission, the council passed an ordinance Tuesday, Aug. 2, which changed the zoning status of Green Valley Trailer Court at 112 Reynolds St. from "trailer or mobile home residential " to "school residential." At this time, CMU does not have plans to build student housing at the site according to Julee Sherman, CMU financial officer, who attended the public hearing. Thirteen trailers and mobile homes currently occupy the site and residents will have until July 1, 2012 to vacate....State achievement scores for the 2010-2011 school year were released Thursday and the results are both promising and predictable. Preliminary Missouri Assessment Program (MAP) scores for all public school districts released by

the Department of Elementary and Secondary Education (DESE) showed steady academic gains throughout the state-including local schools in the Fayette Advertiser readership area. However, the gains did not exempt most schools from "needs improvement" list as defined by No Child Left Behind standards. Fayette, Glasgow, New Franklin, Harrisburg and Boonville Schools join the 84 percent of all school districts in the state which do not meet NCLB standards. Only 16 percent met NCLB standards and one of those was Higbee Schools....Area residents turned out in force for the third annual Favette Festival of the Arts on the courthouse square and the event's 12th annual art show....In spite of a balanced budget, "significant improvements" implemented since an audit four years ago, and the promise of increased revenues beginning next January, Howard County's financial position has been rated "poor" by the state. That word came this week in the quadrennial audit of the county's finances as prepared by the office of Missouri State Auditor Thomas A. Schweich. Officials here, who expected to receive at least a "fair" rating, were chagrined to learn that summaries of the audit had been released to area media outlets before the report was received in the courthouse. None of the criticisms contained within the report suggested anything of a criminal nature, only procedural matters. The auditor's office alleges that many recommendations made in previous audits have not been implemented, but County Clerk Kathyrne Harper and Presiding Commissioner Lowall Eaton say that simply is not true. "Most of what was covered in the report involved comparatively minor things," Harper said. "It's really not that big of a story." Early in her career, Harper, a CPA, had worked for the state auditor's office doing county audits herself. The county's shortcomings in the past were largely the result of mistakes by former county clerk Mark Hill, she noted. "Eighty percent of the problems within the clerk's office have been resolved," Harper said. "We're doing great."....The Peacemaker's Quilt Show, held in conjunction with the Fayette Festival of Arts filled the sanctuary of Linn Memorial United Methodist Church with comforting colors. Proceeds from the event benefitted the Fayette Ministerial Alliance Pantry....A Howard County jailer was dismissed June 16 following allegations that she was providing contraband items to inmates. Julie B. Hubbard, 33, of Glasgow, was arrested by the Glasgow Police Department for charges of providing contraband items to inmates. She was taken to the Howard County Jail and posted 10 percent of a \$2,500 cash-surety bond. Hubbard worked part-time on Sundays as a civilian jailer for the Howard County Jail from November 2009 to June 16, 2011, the day Sheriff Charlie Polson told her she was dismissed and that a criminal investigation would be filed. Hubbard in turn filed a sexual harassment charge on July 6 with the Missouri Commission on Human Rights. Hubbard's statement claims Polson made inappropriate comments of a sexual nature and sent cell phone messages containing sexually explicit photographs. "The sexually explicit cell phone messages were a continuing practice that existed for much of the duration of my employment,"

Hubbard's statement reads. "I did inform the Respondent [Polson] that he was out of control but since the [sheriff] demanded absolute loyalty I felt if I complained about the way the photos made me uncomfortable I would lose my position at the jail." Polson flatly denies the accusations and states they are without merit. He believes Hubbard is filing the sexual harassment charge as retaliation for being terminated. "She filed the suit after I terminated her," he said....Law enforcement authorities here are pursuing nearly 50 leads in an effort to find the person or persons who murdered 39 yearold Howard County resident Jonathan E. Spurling. The victim was found dead in his rural home at 260 HoCo Rd. 117 near Harrisburg (northeastern Howard County) just west of the Boone County line. Sheriff Charlie Polson told the Democrat-Leader that Spurling had taken a vacation day Monday and was last seen by his father, Harold Spurling of Sturgeon. The son had dropped off some meat for barbecuing at his father's home and then left heading toward his own home with the remainder of the meat which he intended to grill outside that evening. The meat later was found in his truck uncooked. Authorities have speculated that Spurling may have unexpectedly encountered an intruder when arriving at the home. Nothing in the house appeared to have been taken, Polson said. Jonathan Spurling worked as a draftsman for a Columbia construction company.... With the start of the Fayette High School football season less than a week away, the new entrance to Thomas S. Davis Memorial Field received some of the finishing touches Thursday night. If all

gates were to be put into place on each side of the ticket office on Friday. The steel fencing — painted by Paul Beeler - between each pillar is scheduled to be assembled. The pavers, which will be on each of the sidewalks in the entrance, will be put into place. The pavers that recognize the project donors were inscribed in Jefferson City, but several blank pavers are still available for inscription for the Bronze Level (\$50), Silver Level (\$150) and Gold Level (\$250). As of Thursday, the project has raised approximately \$44,000 of the estimated goal of \$50,000. Athletic director Geoff Moorehead ordered sod on Monday that will cover the dirt spots on the field side of the entrance. The entrance will opened for Fayette's season-opening football game against South Callaway, with kickoff set for 7 p.m.... The Fayette R-III school district has met the state's annual performance goal and scored a perfect 14 in the state's annual performance report. The 2011-12 tax rate was set at \$4.2095 per assessed \$100 value, compared with the 2010-11 rate of \$4.2241. The assessed valuation has been certified by County Clerk Kathyrne Harper and is subject to adjustment pending appeals before the Board of Equalization and Missouri State Tax Commission.



Throughout the summer, Peggy Guest, with the help of her husband Joe, has been busy painting a mural of local businesses on the side of a building near the intersection of Morrison and Church streets. On Monday, the Missouri Department of Transportation requested the Guests halt their work. Peggy Guest was approached by Sharon Stacy, senior outdoor advertising permit specialist for Mo-DOT. Stacy asked Guest if she was painting the mural, to which Guest replied "yes." Stacy told Guest that she did not think Guest should be doing this painting on a state right of way. Stacy explained to Guest that the state of Missouri had rules and regulations pertaining to advertising on state right of ways. Guest asked, "Do I need to stop painting today?" Stacy said she did not have to stop painting today, but that she would take the case back to the office and let Guest know the next day if she could continue with the mural. Peggy was "flabbergasted." "I didn't know what to think," she said. "I first worried about the 30 businesses that are expecting me to finish the mural."... A provision of a new law which would have restricted teachers' use of social networking sites — such as Facebook — was blocked by a judge on Aug. 26, just two days before the law was to take effect. Cole County Circuit Judge Jon Beetem issued a preliminary injunction putting a provision of the law on hold until at least February. His decision referred to the provision as a "staggering" prohibition of free speech. Missouri lawmakers are expected to revise the law at the special session set to begin Sept. 6.... ### 2011: A Year in Review

### October

In the blink of an eye, the Fayette city park water tower received an artistic touch when crews painted the Falcons logo on the tower. In memory of the late James C. "Spider" Clatworthy, the Clatworthy family donated \$2,200 to the Fayette Athletic Boosters who, in turn, pledged the amount to the city to pay for a gold and black Fayette Falcons logo to be painted on the new city park tower. The logo has a perfect view of the Fayette High School football field just over the city park treeline....St. Paul United Methodist Church will be hosting special celebration services for its 155th year on the corner of Mulberry and Davis St., Fayette, from Oct. 6 through 9. Several events are scheduled during the 4 days, starting with a revival on Oct. 6 & 7, at 7 p.m. Current St. Paul UMC officially opened Dec. 12, 1948. While the new church was being built worship services were held in the auditorium of Lincoln Public School. From 1948 to 1956 several additions and improvements were made on the structure. During the early 1990s, under the leadership of Rev. J.L. Thomas and board chair David Alvis, a multi-purpose fellowship hall, kitchen and basement were added to the east side of the church building. The room was later dedicated as the Alvis Multi-Purpose room....Thirty-seven bands from high schools and junior highs across the state took part. In Class 2 high schools, Fayette took first place in both street marching and field competition. A week earlier at the annual Carrollton Band Day, Fayette also took first place in both divisions among Class 2 schools. The Fayette band is directed by Josh Myers. In other local results, Glasgow took first in street marching, Class 1; first in field, Class 1; and first in outstanding auxiliary. New Franklin took fourth in street, Class 2.... At their regular meeting, Fayette city council members discussed a proposed change to the definition of "family" and selected a contractor to upgrade significant sections of streets. To make city codes consistent concerning the definition of "family," the Planning and Zoning Commission proposes an expanded version to the city's current definition of "family." The expanded definition was discussed at a public hearing. About 20 persons attended the public hearing. Currently, one definition reads as follows: "One or more persons related by blood, marriage or adoption, occupying a dwelling unit as an individual

house-keeping organization. A family may not include more than two persons not related by blood, marriage or adoption." Another existing definition allows up to five members in a household who are unrelated by blood, marriage, adoption/foster. The proposed definition sets the limit of unrelated persons to four... The Fayette High School varsity cheerleaders competed at the Missouri Cheerleading Coach Association 2011 Missouri State Cheerleading Championships for the first time

in school history on Oct. 1. The competition, which was held at the Hearnes Center in Columbia, consisted of 117 schools from around the state. The squad was evaluated throughout various categories such as crowd appeal, cheering skills, jumps, stunts, pyramids, tumbling, choreography, synchronization, transitions, crowd leadership, and incorporation of squad skills.... Two area high school softball teams hoisted first place plaques after winning their district championships over the weekend. The Harrisburg softball team defeated top-seeded Westran 6-2 on Friday evening to win the Class 1 District 9 Tournament and the New

Franklin softball team beat topseeded Pilot Grove 2-0 .... Meeting in regular session, New Franklin city council members opted for a land application treatment of sewer water. Land application sewage treatment system selected The city is required by the Missouri Department of Natural Resources to significantly upgrade its sewer system by April 2012. To meet that goal, council members have researched sewage treatment options, toured one other sewage treatment facility and consulted with an engineering firm, Allstate Consultants of Marceline wrote a preliminary engineering report in March 2010 which outlined the pros and cons of different methods of disinfecting the wastewater before it reenters Bonne Femme Creek and recommended the city utilize "land application" of sewage discharge on about 150 acres of ground. After an hour-long work session prior to their regular meeting, council members opted for the land application method. The cost of the system is estimated to be about \$2 million.... Two cases involving Glasgow native Julie Hubbard are working through the Howard County court system. One hearing in a criminal case which alleges Hubbard provided contraband material to inmates of the Howard County Jail was heard Friday. In that hearing, Hubbard requested that her case be moved to Scotland County. Associate Circuit Judge Hugh Craig Harvey ruled that the case would not be moved to Scotland County but rather to Saline County. Harvey,

associate circuit judge in Saline County, was assigned to the case by the State Supreme Court after both Associate Circuit Judges Mason Gebhardt and Cynthia Suter recused themselves. Also in the criminal case, through her attorney, Frank R. Flaspohler, Hubbard had requested that Deborah Riekhof, Howard County Prosecuting Attorney, be disqualified as prosecuting attorney in this criminal case. However, that request was overruled; so Riekhof is prosecuting the case against Hubbard. The other case is a civil case in which Hubbard alleges sexual harassment by Howard County Sheriff Charlie Polson and retaliation by Prosecuting Attorney Deborah Riekhof. Since Riekhof is one of the defendants named in the case, attorney Jane Drummond of Jefferson City will defend Polson, Riekhof, and members of the Howard County Commission are all named as defendants. Again, Gebhardt and Suter recused themselves and Judge Thomas Nicholas Chapman of the 43rd judicial circuit is assigned to the case. Chapman will hear a request by Hubbard for a change of venue at a hearing in the Howard County Court Thursday, Oct. 20. Chapman is judge of the 43rd Judicial Circuit which includes the northwest counties of Caldwell, Clinton, DeKalb and Livingston.... Barbara Alexander, chairperson of the Lincoln Public School Project Committee, presented a check to Ron McQuitty for continued maintenance and upkeep of the Lincoln Public School Memorial

on East Hackberry. In addition to keeping the site clean and mowed, McQuitty has installed benches and a table for visitors. "I wanted to provide the professional attention and dignity that the site richly deserves," McQuitty said. Sid Sanders and David Stemmons have also helped in building and maintaining the memorial. Fayette's Lincoln Public School operated at the site from 1871 to 1966 for African-American children prior to pubschool integration. The Public Lincoln project School committee

Members of the Howard County Commission are also named as defendants. At a hearing held Thursday in the Howard County court, Judge Thomas Nicholas Chapman of the 43rd judicial circuit determined the case warranted a change in venue. Chapman was named to hear the case after Associate Circuit Judges Mason Gebhardt and Cynthia Suter both recused themselves. Another case involving Hubbard will also be heard outside the county in Saline County. The criminal case alleges Hubbard provided contraband material to inmates of the Howard County Jail.... Howard County Fire Protection firefighters from New Franklin responded to a fire at the residence of Brad Marcum of 2037 Route Z in southern Howard County. When the firefighters arrived they saw flames shooting close to 60 feet in the air from both the front and rear of the trailer. Marcum was not home at the time of the fire. He was later located in Boonville. Firefighters used more than 6,000 gallons of water to extinguish the fire and worked long into the night on hot spots. Howard County Fire Protection Chief David Kunze said the fire is under investigation and is considered suspicious. The State Fire Marshall and DNR are involved in the investigation which continued after the initial investigation. Thirteen firefighters were hospitalized overnight because of chemical exposure at the fire. The firefighters were treated and released.... The Department of Natural Resources, the State Fire Marshall and the Missouri National Guard's 7th Weapons of Mass Destruction Civil Support Team have determined during their Tuesday investigation that the firetic acid. The owner of the home, Brad Marcum, was not home at the time of the fire. Firefighters that became ill at the fire scene had inhaled fumes from the muriatic acid. The firefighters had taken off their masks and were putting out fires that were smoldering in the home. When the water was sprayed on these smoldering fires, the acid fumes were inhaled, causing the firefighters to become ill. All the firefighters that became ill Monday night from inhaling muriatic acid fumes have recovered and were released from the hospital and are doing better. Muriatic acid is one of the ingredients used in the manufacture of the drug methamphetamine....

While the boy, Kain Studley, was standing near a trampoline at a home outside of New Franklin, a dog ran up behind him and bit his face several times. The bite detached his lower eyelid and caused a puncture wound near his right temple. Another incident involving a domestic pet happened in the spring of this year. Rodney Lee's miniature pinscher was attacked and killed by the same dog. Huffman is scheduled to appear in the Howard County Court on Nov. 8 at 9 a.m... A milestone in Howard County transportation needs was achieved Wednesday when contractors completed construction of new twin bridges south of Fayette November 2. The project, which began in June, replaced the 80-year-old twin bridges and includes a left-turn lane on Highway 240 for vehicles leaving Fayette and turning onto Highway 124 heading toward Harrisburg. The new, wider bridges span Bonne Femme Creek and a ditch on Highway 240 at the south edge of Fayette. Widel Inc., of Blackwater, completed the \$1.8 million job by the planned deadline.... A Fayette man charged with attempted rape and other charges

of sexual abuse will have his case heard in Randolph County. Appearing before Presiding Judge Scott A.



Frank R. Flaspohler, Smiley requested, and was granted, a change of venue. A hearing to consider a reduction of his \$100,000 cashsurety bond will be discussed November 8. Smiley was transferred to the Randolph County Jail on Wednesday...A higher court ruled that Terra Road is indeed a public road and not private property belonging to MFA Inc. The ruling ends a dispute between the city of Fayette and MFA Inc. that began nearly three years ago. The Western District of the Missouri Court of Appeals ruled in September in favor of the city that the stretch of roadway known as Terra Road belongs to the city. The case began in November 2008 when MFA filed a suit against the city of Favette contending it owned and paid taxes on a section of Terra Road. MFA had requested the area be declared private property and be closed to traffic. Because of the proximity of MFA property and Terra Road, MFA uses the area often for transport of large quantities of grain and heavy farm equipment. MFA officials cited public safety as an additional reason for declaring the area private resignation as the Fayette city council members discussed options for dealing with the derelict Colonial Mercantile property on Main Street. At this point it seems the city will have to be responsible for the repairs and/or demolition of the Colonial Mercantile Building at 103-105 Main St. Proposals were sought for repair of the building. Two came in which ranged from \$62,600 to \$180,000. Council members asked city officials to ask for a revised proposal from one of the contractors before making a final decision. City Attorney Mike Conway suggested the "best of the worst" solution is probably to demolish the building. Building new is cheaper than renovating. The city may be able to recoup some of the expense through a special tax lien placed on the building. Council member Megan Hess put it bluntly, "We may have to eliminate a city personnel position in order to pay for Colonial Mercantile repairs. It's a hard reality but it's the truth."... Jennings Premium Meats has placed their project to expand in Boonville on hold according to a source close to the proposed

Charles O'Neal, 26, was convicted of first degree murder in Randolph County Court. Judge Russell E. Steele presided over the case. A later hearing will be held to determine O'Neal's sentence. A crime of first degree murder can mean life in prison without a chance of parole. This was O'Neal's second trial of the same case. ## 2011: A Sports Year in Review

#### January

Jan. 7: Trailing by seven points heading into halftime of the seventh-place game of the New Franklin Tournament, a win didn't look very promising at the time. But the Fayette girls outscored Keytesville 16-0 in the third quarter, returning the favor to an opponent for a change. The Lady Falcons went on to win 43-28 for their first win of the season, snapping an eight-game losing streak.

Jan. 8: The Fayette boys held a five-point lead with less than 40 seconds to play in the championship game of the New Franklin Tournament, but Sturgeon rallied back to win 54-52. Spencer Kelly scored the winning basket with nine seconds left.

For the seventh time in nine years, the Glasgow boys won the Marceline Hoops Tournament. The Yellowjackets trailed by four points heading into the fourth quarter against Marceline, but they extended their perfect record to 8-0 with a 56-51 win. The Lady Jackets lost in the girls championship game 42-37 to top-seeded Milan.

Jan. 14: Nothing could go wrong for Fayette in the final two minutes in the clash of the titans against top-ranked Salisbury. The Falcons ended the game with a 9-0 run during the final 1:46, forcing three turnovers and two missed three-point attempts. Those nine points made a huge difference. Fayette ended Salisbury's run for an undefeated season, knocking off Class 2's top-ranked team 62-53 on Courtwarming night.

Jan. 15: Nothing seems to stop the Clark Middle School girls basketball team these days. The Lady Falcons, after losing their season opener at Columbia Catholic, extended their winning streak to 10 games with a 26-19 win over Salisbury in the championship game of the St. Joseph (Salisbury) Tourna-

Jan. 17: The Harrisburg boys, coming off a third-place finish in the South Callaway Tournament, were playing their fourth game in five days when they hosted No. 10 Fayette in a nonconference clash. Tyler Rasmussen's two free throws with 13 seconds left in the game turned out to be the difference. The Bulldogs climbed back to the .500 mark with a 79-77 upset win over

Jan. 22: For 31 games last season, the Harrisburg girls were the ones being chased. Each opponent hoped it would be the one to cast the Lady Bulldogs' first loss, yet each team hopelessly failed. This time, it was Harrisburg playing the role of underdog for a change. Although it's a position in which the players aren't too familiar, the Lady Bulldogs proved that they can still control perfection's destinv. However, instead of extending perfection, they ended perfection. Harrisburg handed Class 3 No. 2 Hallsville its first loss of the season with a 57-38 win in Mid-Missouri Conference play.

Jan. 29: The Fayette boys basketball team eliminated the last remaining unbeaten team in Class 2. 

In the men's game, three players set career-highs in scoring for the Eagles and returned their game to the uptempo offense of old in a 94-84 win against MidAmerica Nazarene.

Feb. 19: The Central Methodist University men's track and field team won eight events, and placed in 19 out of the 20 events in which they competed, to win the first Heart of America Athletic Conference Indoor Championship in school history. CMU scored 177 team points at the two-day meet hosted by Graceland University in Lamoni, Iowa, to beat three-time defending champion Lindenwood University, who finished with 163 as the runner-up. Senior Edward Stewart was named the outstanding male performer of the meet and was also recognized as the highest individual point-scorer on the men's side with his three individual titles. Stewart swept the individual championships in the 55-meter dash, 200-meters and 55-meter

Feb. 23: The week couldn't have been any better for the Glasgow boys basketball team. After upsetting Sturgeon on the road the night before, the Yellowjackets clinched a share of the Central Activities Conference title with a 65-32 win over Brunswick. Tyler Sanders scored 23 points and knocked down seven 3-pointers on Senior Night. Glasgow won the conference outright two nights later with a win at Keytesville, finishing with an 11-1 CAC record.

Feb. 25: The Harrisburg boys basketball team became the only Howard County area team to go undefeated in the month of February, winning 73-45 at North Callaway. The win gave the Bulldogs another title in the Mid-Missouri Conference, sharing the honor this season with Southern Boone.

**Feb. 26:** The Harrisburg girls basketball team, after dropping its first conference game the previous week to Hallsville, settled for a share of the Mid-Missouri Conference title with the Lady Indians after a 75-44 win at North Callaway.

Former Central Methodist track standout Patrick Stroupe won his first career U.S. indoor national title in the 3,000-meter race walk Saturday. Stroupe, a native of Armstrong, clocked a time of 12:31.24 to win the event at the U.S. Indoor Track & Field Championships. Stroupe's time was more than 37 seconds faster than the runner-up finisher.

The Higbee girls, the No. 7 seed of the Class 1 District 11 Tournament held in Madison, ended their season with a first-round loss to La Plata 68-16. The Lady Tigers finished the season with a 6-16 record.

Feb. 28: The Fayette girls had a combined 0-10 record in the regular season against teams in the Class 2 District 7 Tournament. There was, however, one team in the district they had not played yet this season: Sturgeon. Despite the clean slate, Sturgeon ended Fayette's season for a second consecutive year with a 65-29 win in Harrisburg. Fayette finished the season with a 2-21 re-

The Higbee boys also saw their season come to an end with an opening-round loss in district play. The Tigers lost to Marion County 81-34 and ended the season with a 6-16 record.

New Franklin led for a majority of the first half, but Sturgeon retook the lead with 3:53 to go in the second quarter and never looked back in a 44-33 win to end New Franklin's season with a 10-14 record.

March 2: The New Franklin girls met Harrisburg for the third straight season in district competition. New Franklin lost on Harrisburg's home court in a 51-32 defeat in the Class 2 District 7 semifinals. New Franklin ended the season with a 16-10 record.

March 3: The season wasn't supposed to end like this, not for the Fayette boys. Fayette's last loss, if it were to happen in the postseason, was to take place in Mizzou Arena during the Class 2 Show-Me Showdown. If it came sooner than that, the loss might have been to Salisbury in the district championship game. The loss wasn't expected to come in a 73-65 defeat to Sturgeon in the Class 2 District 7 Tournament semifinals. Fayette ends the season with a 19-6 record.

Although Glasgow held the lead for a majority of the game, Tina-Avalon surged in the fourth quarter for a 51-43 win in the championship game of the Class 1 District 10 Tournament. Glasgow ends the season with a 22-6 record after winning the first 12 games of the season.

March 5: The Harrisburg girls repeated as district champions with a 57-34 win against Salisbury. The district title is the third in four years for Harrisburg.

Central Methodist University senior Edward Stewart repeated as the NAIA national champion in the men's 60-meter hurdles at the 2011 NAIA Indoor Track & Field National Championships. Stewart,

who set a school and NAIA National Championships record in the 60-meter hurdle semifinal earlier at the meet, clocked a time of 7.96 seconds to win the event for the second straight year. Lucas Manring took second place in the men's 800-meters, Roscoe Robinson finished in second place in the men's long jump and Kate Fulton placed third in the women's high jump. All four athletes received NAIA All-American honors

March 9: The Harrisburg girls won at its Class 2 sectional game for a second straight season, topping Sacred Heart 63-30 in Sedalia.

March 12: For the second time this school year, Clopton ended a state run for a Harrisburg girls team, topping the Lady Bulldogs 66-53 in the Class 2 quarterfinals at Moberly Area Community College. The Clopton softball team beat Harrisburg 2-1 in the Class 1 sectionals on Oct. 13. The Harrisburg girls finish the season with a 21-5 record and had the No. 1 ranking in Class 2 at the end of the regu-

March 19: Sophomores Shelby Garrigus and Amelia Truex each set school records, and sophomore Roscoe Robinson posted an NAIAqualifying mark in the first outdoor meet of the season for the Central Methodist University track and field teams at the CMU Open. Battling rain throughout the afternoon, the CMU men scored 126 points to win the team title over runner-up Lincoln University.

March 22: Who says Fayette is purely a basketball town? The baseball team put up a pretty good argument in its home opener against Stover. The Falcons scored 15 runs in the first inning and 12 more in the fourth inning to run away with a 30-3 win in five innings.

#### April

April 1: In his first season on the New Franklin track team, Ben Ridgwell is already improving at a rate much faster than other rookies. Ridgwell dominated the boys discus with a throw of 134'-0", breaking the Bulldogs' 15-yearold school record in the event at the Fayette Relays. He topped his nearest competitor by 22 feet. Sam Kircher also won the girls long jump. The Fayette boys took fifth in the team standings and the girls placed eighth.

April 5: Clark Middle School track head coach Billy Huthman had to be smiling after his teams' first meet of the season at Centralia. The CMS boys cracked triple digits in the team standings, taking second place with 103.5 points behind only Louisiana. The Lady Falcons were fifth in the girls standings with 39 points. The Falcons claimed the title in a couple of events at the meet. Davis Valencia won the boys triple jump with a distance of 34'-5", while the boys 4x400-meter relay also won with a time of 4:32.74.

April 6: Fayette's Lorenzo Estes, New Franklin's Jasmyne

Boggs, Glasgow's Tyler Sanders and Harrisburg's Tyler Rasmussen and Chelsey Kroese were recognized as KRES All-Stars at the annual banquet held at Central Methodist University. Ballots were sent to coaches from 43 high schools representing seven conferences in the North Central Missouri region. The top 15 boys and 15 girls made the cut for the All-Star teams.

April 7: Harrisburg senior Lindsey Roberts signed a letter of intent to play for the Central Methodist University women's basketball team for the 2011-12 season. Roberts finished her senior year by averaging 6.8 points per game, fourth highest on her team. She also tallied 33 3-pointers.

April 8: The Glasgow Yellowjackets and Tyler Sanders took full advantage of a once-in-a-lifetime opportunity. As a part of the 11th annual Frank White Classic, the Glasgow baseball team had the opportunity to play a regular-season game against the Slater Wildcats at Kauffman Stadium, the home of the Kansas City Royals. Sanders paced the night with 16 strikeouts in a 4-1 complete-game victory.

April 9: The Central Methodist men's and women's track and field teams combined to break five school records at the ASICS-CMU/ Susan G. Komen Breast Cancer Awareness Invitational. Junior Rebeca Barajas set two individual school records and was part of a relay school record, while placing in five events for the CMU women.

April 14: The Fayette High School golf team won its first meet under head coach Kirk Besgrove against Hallsville, Harrisburg and Westran. It also means a new hairdo is on the way for Besgrove as well. The Falcons shot a 181 as a team, achieving their goal of breaking the 185 mark. As a result, their lowest individual scorer has the honor of shaving a Mohawk on Besgrove's head.

After nearly one month, Fayette finally has a winner. The Falcons have two winners, to be exact. Having failed to win in any of the boys or girls' events in its first five meets of the season, Fayette won two individual events at Marceline. Senior Mavrick Frerking set a personalbest in the long jump, winning the event with a leap of 18'-2.75", while sophomore Kate Moorehead won her first high school event with a personal-best in the 100-meters with a time of 13.32 seconds.

April 17: Central Methodist University junior Freddie Cabrera recorded eight strikeouts in game one to break the CMU single-season strikeout record as the Eagles picked up a non-conference doubleheader sweep at Clarke University. 

## 2011: A Sports Year in Review

May

May 4: The Glasgow boys and girls may have won the team standings at the Larry Littrell Relays, but the story of the day belonged to Harrisburg senior Haley Heuer. In a span of roughly 15 minutes, Heuer would break her school discus record three times. The final throw registered a distance of 142'-6.5", topping the previous record that lasted for approximately six or seven minutes.

May 7: Although the Central Methodist softball team started the HAAC Tournament as the top seed, the Lady Eagles fell to MidAmerica Nazarene 5-2 in the championship game at Cox Softball Complex. CMU ended the season at 41-15, the best record in program history.

For the second consecutive year, Fayette's Nickie Foland and Harrisburg's Haley Heuer advanced to the Class 2 track and field sectionals. Foland moves on in the 3,200-meters and Heuer advances in the discus.

Glasgow and New Franklin combined to win six events at the Class 1 District 5 meet. The Glasgow girls took second place in the team standings with 101 points, followed by the New Franklin girls with 74.5 points. The Glasgow boys tallied 56 points and the New Franklin boys had 24 points.

May 12: Needless to say, the Clark Middle School track team was happy to see the Glasgow Jr. High Relays were rescheduled. The Falcons' boys team ended the 2011 season by winning the team title at Bob Monnig Community Track.

May 14: Nearly 12 hours after graduation, the Fayette baseball team took to the field for its district opener Saturday against Eugene in New Bloomfield. Fayette's 3-10 season came to an end with a 10-0 loss in six innings.

May 19: Glasgow had plenty of reason to celebrate a 2-1 win over previously unbeaten Pilot Grove in the Class 1 District 11 championship game in New Franklin. A school noted for its basketball prowess, the win marked Glasgow's first baseball district title since it began playing spring baseball in 2007.

May 20: Sam Kircher finally has her gold medal, the one she's been wanting for three years. After reaching the podium four times in the previous two years, she climbed to the summit when she took first place in the Class 1 girls' triple jump with a distance of 34'-9.5". She became New Franklin's first state champion since Courtney

Harrisburg's Haley Heuer took second in the Class 2 girls discus, New Franklin's Ben Ridgwell took third in the Class 1 boys discus, the New Franklin girls' 4x100-meter relay of Taylor Warren, Jasmyne Boggs, Sara Montgomery and Sam Kircher placed third, the Glasgow girls' 4x400-meter relay team of Lindsey Kopp, Carley Brucks, Erin Reynolds and Alex Davis finished in eighth place and Glasgow's Peyton Davis tied for eighth place in the Class 1 girls pole vault.

May 23: The Glasgow baseball team had gotten by in its past three games, winning in low-scoring affairs in each of its three district battles. But taming the bats of the Cairo offense would be another story. The Bearcats slugged 16 hits, including two home runs, in a 14-9 win in the Class 1 Sectional held at Gold Star Park in Glasgow. The Yellowjackets finished the season with an 8-9 record.

May 26: The Fayette Sharks won 14 events in their first home meet of the season. Ethan Harper led the way with four wins.

May 27: Central Methodist senior Edward Stewart equaled his

Four other Eagles earned All-American honors at the meet. Lucas Manring took fourth place in the men's 800-meters, Roscoe Robinson finished in fourth place in the men's long jump, Kate Fulton placed fifth in the women's high jump and Rebeca Barajas had a sixth-place finish in the women's triple jump.

#### August

Aug. 1: Fayette senior Novy Foland signed a letter of intent to play for the Central Methodist football team for the 2011 season. Foland is coming off a highly productive 2010 season with the Falcons. He piled up 131 total tackles (56 solo, 75 assisted) in only nine

Aug. 20: The Fayette football team began its season at the Central Methodist University jamboree at Davis Field. The Falcons lost scrimmages to Southern Boone and Hallsville, but tied Slater in the final meeting of the evening.

Aug. 22: Harrisburg head coach Brian Simpson had a smile that stretched from ear to ear. After all of the hours he and other members of the community had put into getting ready the school's new baseball field for its inaugural game in the fall opener against Glasgow, his team answered the call on the field. Harrisburg pitchers Ethan Beringer and Eric Penton combined to no-hit Glasgow in a 13-0 drubbing in five innings.

Nov. 12: The Central Methodist football team stood toe-to-toe with one of the top NAIA programs in the final regular-season game at Davis Field. The Eagles caught some breaks early, but in the end, NAIA No. 7 Missouri Valley College's size proved to be too much. CMU lost 33-7, ending its season at the .500 mark with a 5-5 record.

Nov. 19: The Central Methodist women's and men's cross country teams ended their seasons at the 2011 NAIA Cross Country National Championships, among the more than 600 competitors present. Kate Olvera was the top finisher for the CMU women's team, running the 5K race in 19:45 for 139th place.
