### January

**Jan. 1:** Fayette residents will have an opportunity to vote on a "local use" tax on the April ballot.

Council members authorized the placement of the proposal that will appear on the April 2 ballot.

If passed, the local use tax would assess 1.125 percent on items purchased out of state, such as products purchased from out-of-state companies via the Internet. Residents now pay the 1.125 percent tax on locally-purchased goods.

Jan. 1: The Howard County Economic Development Council (HCEDC) is currently seeking investments from private entities as well as the municipalities and county entities to join the Moberly Area Economic Development Corporation (MAEDC). Howard County needs commitments of \$80,000 per year for three years prior to joining MAEDC.

Fowler, Marianne Inman, Mark Harbison and Richard Conrow wrote in a Dec. 4 letter to the city of Fayette: "The annual cost of Howard County's membership in the MAEDC is \$80,000...or approximately \$8.16 per resident.

Jan. 12: The Santa Fe Trail monument



Jan. 15: The following candidates have filed for local municipal, school board and other elective offices up for election on April 2. Filing closed at 5 p.m. Tuesday. Marquise Francis, Larry Dimond and Leon Hackley have all filed for re-election for the East, Northwest and Southwest Wards. In the Fayette R-III school district, three have filed for two seats on the school board. Incumbent Michelle Howell has filed for re-election. Also filing are Jessica Quint and Jason Hill. Incumbent Lee Young did not file for re-election.

Jan. 16: At their regular meeting Wednesday, the Fayette R-III Board of Education unanimously approved a No Tax Increase Bond Issue of \$3.5 million for the April 2 election. Superintendent Jim Judd said, "Our buildings continue to wear out. We need to be proactive in staying ahead of building needs. For more than a year-and-a-half we have explored the possibility of presenting a no tax increase bond issue to the voters as a means of financing repairs and upgrades to our school district. With

# January (cont'd)

Jan. 28: This 2013 budget is balanced with expenditures being less than available resources. In several funds, a reserve is anticipated with 2013 marking the first year in recent times a reserve has been budgeted for the General Revenue Fund. An emergency fund has also been established in the General Revenue Fund that exceeds the 3 percent minimum required by law.

A new one-half cent general revenue sales tax that replaced the expiring capital improvement tax for the Howard County Law Enforcement Center began to be collected in 2012. While receipts to the county of said sales tax were for only part of 2012, \$234,000 in additional revenue was received. With continued decreases in state and federal reimbursements and increases in costs of providing county services, this additional revenue was a blessing.

Jan. 29: Jason Monnig, of Monnig Industries, welcomed more then 60 people to the Knights of Columbus Hall to hear the Moberly Area Economic Development Corporation (MAEDC) presentation Tuesday night in Glasgow.

MAEDC is a regional economic development group that represents Randolph, Monroe, and Cooper counties and the city of Moberly. Corey Mehaffy and David Gaines represented MAEDC. They gave an over view of MAEDC and how it operates.

Mehaffy started the question and answer session by informing

everyone that MAEDC does not have any legal or financial ties to Mamtek. Mehaffy also said, "We (MAEDC) are not part of any law suit that involves Mamtek."

**Feb. 22:** At 3:30 p.m., the buildings at 118 and 114 - 116 N. Church St. collapsed. A loud roar and plenty of dust occurred when the building collapsed. No injuries were reported.

**Feb. 26-28:** Tuesday's powerful snow storm left hundreds of households in Howard County without power from four hours to more than 24 hours. Some residences were without power until Friday afternoon.

The weight of the snow caused downed power lines and collapsed roofs at three buildings on the west side of the court-house square in Fayette. Highway 240 (Church Street) was closed after the building collapsed Friday, Feb. 22.

The weight of the snow downed transmission lines, both within the Howard Electric Cooperative system and from its supplier, Central Electric, which also supplies the city of Fayette. At one point on

Tuesday, Howard Electric Cooperative did not have one meter turning.

Both Central Electric transmission lines feeding into Howard County were downed. There were about 20 power poles down in Howard County.

"Less than five percent of the power outages were related to tree limbs in the power lines," Richard Fowler, HEC general manager, said Thursday in a telephone interview.

Neighboring power companies Cuivre River Electric Cooperative, Black River Electric Cooperative and Citizen Electric Cooperative sent a total of 20 linemen to Howard County to help restore power.

"Our employees and outside workers have been high-spirited and dedicated to getting everyone's power back on," Fowler said. HEC has seven linemen.

As of 11 a.m. Thursday, there

were still 650 households without power in Howard County. At press time Friday, 35 households were still without power. "Everyone that has called us will have power back on today (Friday). Feeder lines were back on line by Thursday afternoon. "This is the worse power outage I have seen since I have been here," Fowler said, who has worked at HEC for 22 years.

March 23: In November 2012, a hunter in Howard County shot what has been recently confirmed by the Missouri Department of Conservation (MDC) to be a wolf. According to MDC Resource Scientist and Furbearer Biologist Jeff Beringer, tissue samples from the 81-pound male animal, mistaken as a coyote by the hunter, were sent to the U.S. Fish and Wildlife Service (USFWS) for genetic testing. Recently received DNA test results confirm that the animal was a gray wolf from the Great Lakes states of Minnesota, Wisconsin or Michigan.



March 30: EO Recycles is back in business! After the collapse of the roof at 114 N. Church St. from the Feb. 26 snowstorm, the employees of EO Recycles have been working in less than ideal conditions. After ensuring that the building was safe to enter, employees were

able to remove property in order to resume operations. Operations were only halted for four days, but the damage left the business literally without a roof over their heads. Employees worked mostly outdoors until a new location could be found. Last week, the EO Board of Directors voted to sign a lease with the owners of the building located at 105 N. Cleveland Ave., where the Fayette Farm and Home was previously located.

### April

April 2: Everything passed: Local use tax proposals, Fayette's school bond issue, and road district tax proposals.

Voter turnout was low: 16 percent of Howard County registered voters cast ballots. Boone County had a turnout of 19 percent. Randolph County had 10 percent of registered voters go to the polls.

Fayette School Board incumbent Michelle Howell was returned to office while Jessica Quint was elected as the newest member to the board

April 6: Howard County has raised the funds necessary to join the Moberly Area Economic Development Corporation (MAEDC). Howard County Economic Development Council President Richard Fowler said, "We have the funds to join MAEDC. Contracts will be signed next week." The \$80,000 a year needed to join the group was raised through public and private donations. There are over 20 public and private entities that donated funds to finance Howard County joining MAEDC. Howard County will have a three-year commitment to MAEDC.

April 6: After a lengthy investigation the M.U.S.T.A.N.G. Drug Task Force and the Boonville Police Department report that Grand Jury Indictments were issued and with assistance from the Cooper County Sheriff's Department, Howard County Sheriff's Department, Fayette Police Department, and the Missouri State Highway Patrol, 19 people were arrested for the sale of drugs in Boonville and Cooper County.

April 8: Wayne Schlotzhauer, member of the Howard County Regional Water Commission, updated the council on the progress of the Commission towards the establishment of a regional water distribution system that will serve the cities of New Franklin and Fayette and customers of the Consolidated Public Water Supply District No. 1 of Howard County.

The main obstacle to moving forward is resistance from landowners to grant easements. "We're trying very hard to be neighborly," Schlotzhauer said. The Commission has offered one dollar per foot of easement to make the deal more palatable to landowners, but there are still a number who are not signing the easements at this

Schlotzhauer commented that the regional water supply system "is better for everyone." It will result in better quality water that will be within 10 cents of what water customers are paying now. He mentioned that the \$10 million in grants and low-interest loans made available through USDA-Rural Development is an opportunity that should not be missed.

"This should have taken six months, but it's been a year now," Schlotzhauer said.



#### January

Jan. 3: The Central Methodist men's basketball team went on the road to defeat Graceland 84-64, giving head coach Jeff Sherman his 500th career win at his alma mater. Sherman was in his 28th season with Central Methodist and Eagles supporters began chanting "500!" behind the team bench during the game's final seconds.

Jan. 5: For the second straight season, the Glasgow boys and girls basketball teams swept the Marceline Hoops Tournament championship games. Trisha Mc-Millan scored 12 points to lead the Glasgow girls to a 41-36 win over Marceline, while Reid Littrell had a double-double of 19 points and 13 rebounds to lead the Glasgow boys to a 54-50 win over the Tigers.

Less than 24 hours after the Fayette girls' most lopsided win of the season, the Lady Falcons picked apart Jamestown 56-33. Fayette, the No. 8 seed in the New Franklin Tournament, won the consolation trophy.

**Jan. 8:** In a 63-57 overtime win against Pilot Grove, New Franklin senior Tyler White scored his 1,500th career point and had a team-high 18 points for the Bulldogs.

**Jan. 18:** Reid Littrell's 28 points were more than Keytesville had in 32 minutes against Glasgow in the Yellowjackets' 92-18 win on the road. Littrell scored his 1,000th career point in the contest.

Jan. 26: In a true "David vs. Goliath" matchup between Class 1 Glasgow and Class 4 Marshall for the Slater Wildcat Classic championship, Nikki Fuemmeler did all she could to lead Glasgow to victory, scoring 32 points and grabbing 16 rebounds. However, Marshall stormed back in the fourth quarter to send the game into overtime. The Lady Owls won the extra period and the game, 44-41.

Jan. 27: It wasn't a No. 1 stunner. It was a No. 1 beatdown. Joel Monnig had 14 points and 13 rebounds and earned the game's Most Valuable Player award. Glasgow knocked off Class 1 No. 1 Meadville 59-42 in the MFA Oil Shootout at Mizzou Arena.

Jan. 29: It wasn't exactly the ending Fayette head coach Chris Kendrick had in mind, but he'll take it. Zach Cook maneuvered his way through the Marceline defense in the lane and, while moving to his right, hoisted up a shot with his left hand that went through the hoop with 9.6 seconds showing on the clock. That basket earned Fayette a 55-54 win over the Tigers, capping the Falcons' season sweep of Marceline.

#### February

Feb. 2: On a day dedicated to the memory of avid Central Meth-

odist basketball fan Bill Holman, the Eagles played one of their best games of the season. Elliott Black scored 27 points to lead Central Methodist to an 83-73 win over MidAmerica Nazarene — ranked No. 17 in the NAIA — in the "Bill Holman Blow Pop Game."

What happened after the final buzzer sounded in the Central Methodist and MidAmerica Nazarene women's basketball game was the biggest news of the game. The Pioneers came away with a 64-63 win, making a basket with 1.5 seconds left on the clock. When the Eagles in-bounded the ball to attempt to make a desperation shot before the buzzer, MidAmerica Nazarene had more than five players on the court. Unfortunately for the Eagles, the additional player on the court went unnoticed by the referees.

**Feb. 7:** Another chapter was written into the Sherman family chronicles at Puckett Field House. Serving as the acting head coach for the Graceland men's basketball team, Matt Sherman and the Yellowjackets stunned the Heart of America Athletic Conference by going on the road and upsetting Central Methodist 46-42 in Sherman's debut as a collegiate head coach.

**Feb. 8:** In a tough battle between two Howard County rivals, Glasgow came out victorious on Homecoming night. The Glasgow girls avenged an earlier regularseason loss to New Franklin with a 35-33 win. In the nightcap, the Glasgow boys held off a second-half comeback to edge the Bulldogs 50-47.

**Feb. 9:** The Central Methodist women's basketball team defeated

Avila 87-61 for its 20th win of the season. It was the first 20-win season for the Eagles since the 1999-2000 campaign.

**Feb. 12:** Harrisburg athletic director Steve Combs announced the Bulldogs hired Travis Kinkade to be the high school football head coach for the 2013 football season.

Feb. 20: The third time was the charm for the New Franklin girls basketball team against Salisbury. Aly Hundley scored 19 points, which included six free throws in the final minute of the game, lifting New Franklin to a 48-41 win over Salisbury in the Class 2 District 7 semifinals. Before the game, New Franklin was 1-7 against teams which finished the season with 20 wins

After winning the "District of Doom" championship each of the past three seasons, the Harrisburg girls' run finally came to an end. Sturgeon ended Harrisburg's district championship run with a 63-45 win in the other semifinal game.

Less than 24 hours after his high school basketball career came to a close, New Franklin senior Tyler White made an announcement that turned the school's attention to baseball season. White signed a National Letter of Intent to play baseball next season at North Central Missouri College in Trenton.

Feb. 22: Even as the Fayette boys entered the Class 2 District 7 semifinal against Sturgeon as underdogs with 17 wins, the Falcons had yet to prove to critics they could win the big game against a powerhouse team. Well, as the No. 6 seed, they found a way to silence their detractors. Fayette went on the road and defeated No. 2 Sturgeon 52-51 to advance to the Class 2 District 7

championship game, coming from behind in the final 90 seconds of the game to pull off the upset. The following day, Fayette's season ended with an 82-34 loss to the eventual state champion Salisbury in the district championship.

Feb. 23: Glasgow's Class 1 District 9 title showdown with Community was not one for the faint of heart. It did, however, have all the makings for a dramatic finish: a key injury, physical play in the paint and multiple defensive stands by the top-seeded Yellowjackets. Ultimately, Glasgow would need the extra four-minute period to hold off the resilient Spartans, taking home the district championship with a 52-51 overtime victory. It was the Yellowjackets' 34th district championship.

The Glasgow and New Franklin girls, on the other hand, came up short in their efforts to win a district title. The Glasgow girls, competing against Chamois and NCAA Division I recruit Miranda Brandt, lost the Class 1 District 9 championship 47-37. It was the second time in as many seasons Chamois ended Glasgow's season. The New Franklin girls, after upsetting Salisbury in the semifinals, couldn't beat top-seeded Sturgeon on its home floor. The Lady Bulldogs ended their 20-win season with a 42-33 loss.

**Feb. 28:** The Glasgow boys basketball team made its second straight appearance in the Class 1 playoffs, but this run wouldn't quite reach the Final Four. The Yellow-jackets surrendered a fourth-quarter lead and fell to Marion County 50-48 in overtime, ending the season with a 23-6 record.

#### March

March 2: The Central Methodist men were unable to upset Evangel on the road for a second time this season during the HAAC Tournament semifinals. Evangel went on an 18-0 run in the second half to secure a 77-55 win over the Eagles, ending Central Methodist's season with a 19-13 record.

Central Methodist's DeMarcus Jackson and Kate Fulton earned All-American honors at the NAIA Indoor Track and Field Championships. Jackson finished third in the men's 60-meter dash with a time of 6.76 seconds. Fulton earned All-American honors for the third straight season, tying for fifth place in the women's high jump with a height of 5'-5".

March 5: Three days after upsetting Benedictine in the conference tournament semifinals, the Central Methodist women's basketball team lost to MidAmerica Nazarene in the championship, 77-71.

March 10: After going 1-3 in pool play, the Central Methodist softball team won three straight games to claim the championship

of the Silver Bracket at the Gulf Coast Invitational in Mobile, Ala. The Eagles beat LSU-Alexandria 12-2 in the championship game.

March 13: The Central Methodist women's basketball team received an at-large bid to the NAIA Division I National Tournament, which was held in Frankfort, Ky. The Eagles drew the No. 8 seed in their quadrant and faced Oklahoma City, the defending national champs, in the first round. The Stars dominated the game, especially in the opening minutes, to win 74-39. Central Methodist finished the season with a 25-8 record.

March 21: After 25 years of coaching baseball, Fred Smith announced he was leaving the game. Smith revealed his plans to retire as the head coach of the Central Methodist baseball team at the end of the 2013 season to take a principal job at nearby Boonville Middle School. Smith had been coaching the Eagles since the 2008 season.

March 28: The Fayette boys and girls track teams opened the 2013 season by hosting the Fayette Relays. The boys finished in fourth place, while the girls tied for fifth place. Glasgow finished in second place in both the boys and girls standings. As for individual performances, Fayette's Kate Moorehead and Glasgow's Ethan Thompson each won four medals at the meet.

March 29: Central Methodist junior pitcher Aubrey Utley tossed a complete game in the second contest of a doubleheader at Nebraska Wesleyan. Utley moved ahead of former CMU pitcher McCall Kenney for the most wins in school history, earning her 56th career victory at Central Methodist.

#### April

April 4: In their first home meet of the season, the Fayette golf team defeated a perennial powerhouse. Senior Kirby Schoephoerster and sophomore Sam Zimmel tied for meet medalist honors, shooting a 7-over par 42 to help lead Fayette to a team score of 189, beating defending Class 1 state champion Sacred Heart by nine strokes.

April 6: Twenty-one batters up, 21 batters down. Central Methodist senior left-hander Drew Greiwe pitched a perfect game in the first game of a doubleheader at Graceland University, the first perfect game in Central Methodist history. Greiwe struck out nine batters in his complete-game victory.

In the second game of the HAAC doubleheader, the Eagles defeated the Yellowjackets 10-7, giving head coach Fred Smith his 100th victory at Central Methodist.

April 9: The numbers from the baseball game between Fayette and Tolton Catholic at Legion Field in Columbia are staggering, to say the least. It took nearly three-and-a-half

hours and three extra innings, but Fayette stole a 16-12 win, its second road victory of the season. The Falcons struck out 21 times. Fayette committed 12 errors defensively. But the Falcons pushed through in the top of the 10th for four runs. Sam Miller picked up his first career varsity pitching victory.

**April 13:** Harrisburg, the No. 1 seed in the Calvary Lutheran Tournament, defeated Belle 2-1 in the championship game in Jefferson City to win the tournament.

**April 16:** Boonville native Tyler Lieberman fired a two-under par 69 on the second day to finish six-under par in the Eagle Open and win the event while also leading Central Methodist to the team championship.


**April 20:** The Fayette baseball team finally avoided the play-in game of the Lewis & Clark Conference Tournament, earning an automatic berth to the semifinals as the No. 3 seed. Fayette brought an end to a lengthy drought after defeating Salisbury 3-2 on the road in the tournament semifinals, advancing to its first conference championship game since 2004. The Falcons lost in the championship game to Westran by a score 15-5.

The Glasgow baseball team beat Madison in the first semifinal game of the Glasgow Tournament — which was played in New Franklin — but New Franklin bulldozed through the bracket, beating Meadville in the other semifinal game and then topping Glasgow 14-1 for the championship of the inaugural tournament.

April 24: The Central Methodist softball team secured its third appearance all-time in the NAIA National Championship. The Eagles increased the longest winning streak in school history to 14 games with 5-0 and 4-0 wins over Evangel at Cox Softball Complex to win the Heart of America Athletic Conference regular-season title.

The Glasgow boys track team didn't just win the Central Activities Conference championship. They pulverized the playing field. The Yellowjackets posted 253 points at the conference meet, which was moved from Glasgow to Westran because of wet conditions. Glasgow's boys nearly doubled up its nearest opponent to win their ninth straight conference title. The Glasgow girls won their 21st conference title in 25 years, avenging last year's loss to New Franklin. The Lady Jackets finished the day with 178 points, just 6.5 points ahead of New Franklin.

April 24: Tyler Hull had a banner day, both on the mound and at the plate, against Salisbury. Hull pitched a no-hitter with nine strikeouts and belted a grand slam in the second inning, leading New Franklin to a 14-0 win at Salisbury.

April 27: Central Methodist pitcher Aubrey Utley threw her second career no-hitter, highlighting the Eagles' softball doubleheader sweep of Baker.

April 28: The 37-year drought is over. Central Methodist's Mike Wagner turned a game-ending double play at Estes Field against Culver-Stockton College to give the Eagles their second-ever Heart of America Athletic Conference baseball championship and first since 1975. The Eagles won the league outright in the first contest on Senior Day by a score of 15-4 on the strength of four home runs, two by Jesse Zellner.

April 29: Nickie Foland and Max McKinney each brought home a pair of conference titles from the Lewis & Clark Conference track meet. Foland won the boys pole vault and 3,200-meters, while McKinney won the 100-meters and 200-meters.

The Fayette golf team took second place in the Class 1 District 3 Tournament at Tanglewood Golf Course in Fulton, allowing the entire Fayette team to advance to the sectional round with a score of 394. Louisiana won the district title.

April 30: The Central Methodist men's golf team kept the school's championship express rolling, capturing the program's first Heart of America Athletic Conference title. The Eagles posted a team score of

May 4: The Fayette girls track team ended a four-year drought, advancing past the district meet for the first time since 2009 by moving the 4x100-meter relay team to the Class 2 sectional meet with a fourth-place finish a districts in Fayette. On the boys side, the Falcons qualified their 4x100-meter relay team as well, in addition to

Nickie Foland in the pole vault.

May 5: Central Methodist infielder Lauren Geringer hit three home runs, including a grand slam, as the Eagles rolled MidAmerica Nazarene 19-8 in five innings to win their second straight Heart of America Athletic Conference Softball Tournament championship.

May 6: Central Methodist University announced that Nate Breland had been named the new head coach of the baseball program, replacing Fred Smith.

The Glasgow girls track team won the 4x400-meter relay, the final event of the day, to win the Class 1 District 5 championship. Glasgow finished one point ahead of Santa Fe with 105 points.

May 10: The Central Methodist baseball team had its season come to an end in the Opening Round portion of the NAIA National Tournament. Oklahoma Baptist rallied to beat the Eagles 7-6 in an elimination game. Central Methodist, the No. 4 seed of five teams in its bracket, finished the season 25-

May 11: At the Class 1 and Class 2 sectional track meet at Boonville, Glasgow qualified 17 athletes for 18 events in the upcoming state track and field meet. New Franklin qualified for state in eight

May 14: On the second day of the Class 1 State Golf Championship in Bolivar, Fayette senior Kirby Schoephoerster shot an 18-over par 90, finishing with a two-day total of 182 to finish in a five-way tie for 47th place.

Central Methodist ended the softball season with a 1-2 finish in Opening Round portion of the NAIA National Tournament. After beating Morningside, the Eagles' season came to an end with a 7-4 loss to Williams Baptist, ranked No. 6 in the NAIA. Central Methodist finished with a 35-12-1 record.

May 15: After losing the season opener at home to Pilot Grove, the New Franklin baseball team sought revenge in the Class 1 District 10 championship game. Tyler White and Tanner White had back-toback two-run singles to open the floodgates of a 9-1 New Franklin win, the Bulldogs' second straight district title

Ethan Beringer scattered three hits in a complete-game victory, leading the Harrisburg baseball team past the Cardinals 8-2 in the Class 2 District 7 tournament championship game. It was Harrisburg's first district title since 2005.

May 16: Central Methodist finished the third round of the NAIA Men's Golf National Championship 27th overall, concluding its first-ever run in the national tourna-

May 17-18: New Franklin and Glasgow combined to medal in 13 events at the Class 1 State Track and Field Championships at Jefferson City. The New Franklin girls 4x100-meter relay fell short of defending its state title, taking third place in the finals. New Franklin's Sara Montgomery and Glasgow's Ethan Thompson each earned three medals at the state competition.

May 22: The New Franklin baseball team held the upper hand for much of the Class 1 quarterfinal game against Sturgeon, but Sturgeon answered last in a 3-2 win over New Franklin, with Spencer Kelly outdueling Tyler Hull. New Franklin won its sectional game the day before against Stoutland 12-1.

May 25: The Central Methodist men's track 4x100-meter relay team earned All-American honors at the NAIA Outdoor Track and

Field Championships, finishing in eighth place with a time of 41.82 seconds.

June

June 9: Hank Hilderbrand came close to winning his second straight championship at the 2013 Mid-Missouri Soap Box Derby, which was held in downtown Columbia. After winning the super stock division last year, Hilderbrand took second place out of six competitors in the masters division this year.

June 27: Fayette's lengthy Jr. Babe Ruth winning streak that lasted nearly two full seasons may have come to an end in the past week, but the Falcons still had a reason to celebrate. Fayette wrapped up league play with a doubleheader sweep of Glasgow, winning the first game 16-3 and the second contest 19-8 at Gold Star Park to claim its second straight Quad Cities league championship. The Falcons had a season record of 11-1.

July

July 5-7: New Franklin's Sara Montgomery competed at the Down Under Games, which were held in Brisbane, Australia. Montgomery ran in the track and field games, competing in five different events. Her best finish came in the 4x400-meter relay, where she placed fifth.

July 25: The Quad Cities Jr. Babe Ruth All-Stars were making their first appearance at the state tournament in several years. Quad Cities got off to a fast start, but a sluggish finish amounted to a 9-8 come-from-behind victory for Southwest Ozark in the first round. Quad Cities lost the following day to Mineral Area Nationals to go 0-2 in the double elimination tourna-

August

Aug. 23: After not competing in a jamboree last season, the Fayette football team hosted a four-team jamboree at Central Methodist's Davis Field. It was also the first time Harrisburg suited up for high school football action. Other teams competing include Slater and Summit Christian Academy.

Aug. 29: Alyson Fuemmeler opened the 2013 softball season in spectacular fashion. The Glasgow senior tossed a no-hitter in the Lady Jackets' season opener, striking out 11 of the 16 batters she faced in a 12-0 win over Keytesville.

#### September

Sept. 3: Harrisburg head coach Travis Kinkade had spent months preparing for the first game in Harrisburg High School football history. It may have been a Tuesday night, but it felt like a Friday night atmosphere. The Bulldogs came from behind in the fourth quarter,

with Jacob Rudkin scoring the tying touchdown and Blake Williams tacking on the 2-point conversion to give Harrisburg a 14-12 victory in its inaugural high school football

After several years of absence, cross country was back at Glasgow and Harrisburg. For the Glasgow girls, the first meet of the season at Salisbury showed plenty of promise. Out of six teams, Glasgow finished second, placing behind defending state champion Salisbury. The Glasgow boys also finished in third place.

Sept. 6: The start of Fayette's football game at North Shelby wasn't too thrilling. The finish wasn't particularly spectacular either. That's OK. The middle was pretty eventful for the Falcons. Jason Esau rushed for 189 yards and three touchdowns, while Collin O'Connell had 118 yards rushing and two touchdowns, as well as 21 total tackles in a 38-20 win over the Raiders. It was Fayette's first win of the season.

**Sept. 7:** For the first time since 2008, the Fayette softball team won a tournament. Playing a roundrobin format at the inaugural Prairie Home Tournament, Fayette opened the morning by dominating Otterville 21-6 and then, in a thrilling fashion, scored the winning run in the bottom of the seventh inning to defeat host team Prairie Home 3-2 in the afternoon. Kenzie Smentkowski drove in the winning run with a triple, scoring Minari Hirokawa against Prairie Home.

Sept. 14: Maurice Coon rushed 16 times for 164 yards and two touchdowns, leading the Central Methodist football team to its first win, 38-31, at Bethel College. The Eagles rushed 61 times for 407 yards, second-highest in school his-

Sept. 19: It has been a long road back to the top, but this year's New Franklin softball team wasn't going to be denied. The Lady Bulldogs clinched at least a share of the Central Activities Conference title, knocking off defending CAC champion Sturgeon 6-3 at home.

**Sept. 27:** There is nothing like winning on Homecoming. But if you can't win on your Homecoming, the next best option is to spoil someone else's Homecoming. It took three tries in three consecutive weeks, but Fayette finally got its Homecoming win at Slater. The Falcons overcame a 12-point deficit in the first half and Jason Esau scored the go-ahead touchdown with 1:44 left on the clock, giving Fayette a 27-20 win against the Wildcats to start the Lewis & Clark Conference slate.

New Franklin already had at least a share of the CAC softball title, but a win at Glasgow would give the championship to the Lady

Bulldogs outright. Alyson Fuemmeler did everything she could to hand New Franklin its first conference loss, striking out a career-high 17 batters. However, New Franklin rallied to score two runs in the seventh, sending the game into extra innings. New Franklin came away with a 3-2 win in nine innings at Glasgow.

#### October

Oct. 1: Central Methodist University announced that football head coach Jody Ford had been diagnosed with cancer. As Ford fought his battle with cancer, associate head coach Miguel Paredes served as the Eagles' acting head coach on days when Ford was un-

Oct. 4: In a game that accumulated hundreds of yards — whether it was on the ground or through the air, or even on special teams or through interception returns — the final outcome was determined by a matter of inches. Fayette, which trailed by 20 points in the second quarter, rallied all the way back to take the lead in the fourth quarter. However, the Falcons came up short on a late 2-point conversion, and Paris left Fayette with a 42-41

Oct. 7: The Harrisburg girls golf team didn't win the Class 1 District 5 tournament, but the Lady Bulldogs qualified as a team for the sectional round. Harrisburg came in third place with a 458. Glasgow also qualified a pair of golfers for the sectional round as well.

Oct. 9: The Fayette softball team has been down to its final three outs with the season on the line several times over the years. Once again, that was the case during the play-in game of the Class 2 District 14 tournament at Higginsville. Trailing 1-0 at the start of the seventh inning, Fayette dominated the inning and scored four runs, keyed by a two-run single from Rachael Bishop. The Lady Falcons then shut down Knob Noster in the bottom half of the inning for the 4-1 win. It was Fayette's first district win since 1995. Fayette lost 11-1 the following day to Higginsville, ending the season with a 9-14 re-

Oct. 11: Facing Harrisburg in a rematch of last year's Class 1 District 7 championship game, New Franklin picked the perfect time to bust out of its offensive slump. New Franklin scored 11 runs in the first inning, which set the tone for a 20-4 victory in three innings to claim the school's 17th district softball title. Aislinn Himmelberg hit two home runs and had six RBIs.

Oct. 19: New Franklin had beaten Sturgeon in the Class 1 sectional round to move to the quarterfinals, leaving the Lady Bulldogs with a date against St. Elizabeth for

Oct. 25: New Franklin finished in fourth place in Class 1 at the state softball championships at Springfield. In a thrilling semifinal game, Maysville outlasted New Franklin in a 4-3 win in nine innings. The Lady Bulldogs turned around and lost to Walnut Grove 13-3 in the third-place game.

Oct. 31: Mitchell Farr made his Central Methodist debut a memorable one, making a school-record 12 3-pointers in the Eagles' 70-69 win over No. 21 Park University in the MidAmerica Nazarene Tip-Off Classic.

#### November

Nov. 1: The Fayette football team entered the Class 1 playoffs as the No. 5 seed in District 6. Fayette fell behind 30-0 in the second quarter against Putnam County, then cut that deficit down as low as 10 points in the fourth quarter. However, Putnam County scored again in the final minutes to seal a 42-26 victory, ending Fayette's season at

Nov. 9: All four runners from Glasgow and Harrisburg — Abby Draffen, Hayden Hackman, Caitlin

Yung and Macy Arp — finished in the top half of their respective races at the Class 1 State Cross Country championships. Draffen received All-State honors by finishing in 21st place in the Class 1 girls race with a time of 21:40.69.

Central Methodist sophomore Cris Renteria sprinted past Missouri Valley's Phillip Cheriyout in the final 50 meters to capture the 2013 Heart of America Athletic Conference title in cross country.

Nov. 13: The Central Methodist men's basketball team pushed Columbia College, the No. 4 team in the NAIA, to the brink. Mevlin Tillman's 3-pointer with 4.9 seconds left in the game tied the score, but Columbia College's Devin Griffin jump-stopped, splitting two defenders and made a 12-footer at the buzzer to give the Cougars an 81-79 win.

Nov. 16: Playing in a fairly hostile atmosphere for a middle school basketball game, the Fayette boys essentially played a road game against Slater for the Lewis & Clark Conference Tournament championship. The Falcons trailed by as many as nine points in the first half and were down five points with three minutes to play, but they rallied time and time again, including in the game's final minute to secure the conference championship with a 41-36 victory over Slater.

Nov. 23: Central Methodist's Cris Renteria finished 62nd place

at the NAIA Men's Cross Country National Championship on Saturday at Rim Rock Farm in Lawrence, Kan.

Nov. 30: Melvin Tillman led the Eagles with 18 points and surpassed 1,000 career points scored in an 82-68 Central Methodist victory over Missouri Baptist in the Hampton Inn Thanksgiving Classic at Columbia College.

#### December

Dec. 3: Glasgow senior Nikki Fuemmeler scored her 1,000th career point in the first quarter against Westran and finished with a gamehigh 25 points, leading the Lady Jackets to a first-round 62-21 win over Westran in the Glasgow Tour-

Dec. 4: After winning 13 consecutive games in the Glasgow Tournament, the Glasgow boys saw their four-year run come to an end in the quarterfinals. Top-seeded Cairo handed Glasgow a 56-45 loss, the Yellowjackets' first loss in this tournament since 2008.

Dec. 5: It was the first week of December, but the battle between the Harrisburg and Glasgow girls in the semifinals of the Glasgow Tournament had a district feeling to it. In a rematch of last year's championship game, Harrisburg got its revenge after being denied a fifth-straight title last year. The Lady Bulldogs pulled away with a 21-point performance in the fourth guarter to win 50-44.

Dec. 7: For each of the previous four seasons, the New Franklin girls had played second fiddle time and time again, tournament after tournament. Well, New Franklin wasn't settling for the role of bridesmaid anymore. New Franklin won the championship game of the Glasgow Tournament, and the top-seeded Lady Bulldogs defeated Harrisburg 38-30, winning the tournament for the first time since 1998.

The Harrisburg boys fell in the tournament championship game for the second straight season, this time losing to Cairo 66-56.

Dec. 10: It may have been a typical blowout win for the Glasgow boys basketball team against a struggling conference opponent, but it was a milestone win for head coach Mick Cropp. The Yellowjackets' 58-30 win at home over Brunswick gave Cropp his 250th career win in his 12th season as Glasgow's head coach. Through 11 full seasons and the first five games of his 12th season, Cropp has compiled a 250-73 record at Glasgow.

Dec. 19: After struggling in the first six games, the Fayette girls finally found their groove. Fayette scored at will, which included a 15-0 run. By the time the Lady Falcons were done running Smithton ragged, Fayette had won 58-46, its first victory of the season.
